15. APOLOGIES.

Apologies for the inability to attend the meeting were received on behalf of Councillor Joe Mooney.

16. DECLARATIONS OF INTEREST.

Councillor Royce Longton declared a Personal Interest in Agenda Item 3 (Minute 17).

17. WASH COMMON LIBRARY

Councillor Royce Longton declared a Personal Interest in this matter.

Councillor Mike Rodger introduced the report (Agenda Item 3) in relation to Wash Common Library. He referred to the background behind the decision to close the Library, specifically in relation to Government guidance (ODPM) on the level of Council Tax increase considered to be acceptable for 2004/5.

MOTION:

"That the Council re-affirm its previous decision to close Wash Common Library."

In introducing the following Amendment, the Council noted that the Conservative Group had circulated, with the agenda, and had subsequently issued a revised version of, a Financial Options report proposing various savings from the 2004/5 revenue budget in order to secure the retention of the Wash Common Library. The revised report also referred to a proposal from Total Oil to provide, in principle, funding of £10,000 in order to assist with the retention of the Library.

AMENDMENT proposed by Councillor Graham Jones and seconded by Councillor Keith Chopping:

"That

- 1. the Council agree to re-open the Wash Common Library immediately;
- the Council agree to re-instate the £22,000 in the revenue budget needed to run Wash Common library;
- the Council meet this cost by allocating a saving of £12,000 from an underspend on Members' pensions for 2004/5 and by agreeing in principle to accept funding of £10,000 from Total Oil;

as a fallback position, should the funding from Total Oil not materialise, the Council meet this cost by allocating the full saving of £13,500 from an underspend on Members' pensions for 2004/5 and by adopting Option 2.1 of the Financial Options paper to save a further £8,500.
