### 1. Background

- 1.1 The Council's Corporate Plan 2003-2008 is reviewed annually to reflect changes in circumstances, feedback from stakeholders and the lessons learnt during the previous year. This is the first 'refresh' of the Corporate Plan and is called "Update 2004: Building on Success". Members are asked to refer to "Building on Success" which is attached for further information. Copies of all appendices and detailed actions plans are available on request. Summary versions of the updated Corporate Plan will be produced following approval for circulation to partners, staff and stakeholders.
- 1.2 The 'Refresh' is built on the Corporate Plan 2003-2008 that sets out the Council's vision and key priorities for the next five years. It draws directly on the West Berkshire Community Strategy and brings together a number of key strands, which will have a major bearing on the Council's future direction and activities.
- 1.3 Together with the Medium Term Financial Strategy the Corporate Plan 'Refresh' provides the policy and financial framework for service planning, performance management and resource allocation.
