#### 12. APOLOGIES.

There were no apologies for absence received.

#### 13. MINUTES.

The Minutes of the meeting held on 12<sup>th</sup> December 2008 were approved as a true and correct record and signed by the Chairman.

#### DECLARATIONS OF INTEREST.

There were no declarations of interest received.

#### 15. WBC PLAN FOR THE PUBLIC SECTOR SKILLS PLEDGE.

Robert O'Reilly introduced a verbal item (Agenda Item 4) in response to emails being generated by the Local Strategic Partnership pertaining to the economic downturn and improving skills for local residents. The Council had signed up to the Public Sector Skills Pledge which sought to get all employees up to a standard of level 2 qualifications (the equivalent of 5 GCSEs). The Council had received a one-off Government Grant of £26k which it would use to employ consultants to identify employees and contractors that did not meet this standard and help to encourage them to undergo training to reach the Level 2 qualifications most notably in ICT, Mathematics and English. The provision of the education would however be free and the Council would act as an enabler to put them in contact with providers. The Committee requested that a report on initiatives being undertaken by the Council be provided to the LSP.

A report seeking to formalise and expand on work experience undertaken within the Council would be considered by Corporate Board in February 2009 and this report would suggest that work experience activity should be co-ordinated across the Council by HR.
