An objection has been submitted direct to the Planning Inspectorate on behalf of United Asphalt Ltd, which operates an asphalt plant from Theale Depot to the south. UA raise no objection in principle but have stated that they object unless any grant of planning permission includes appropriately worded conditions ensuring the issue of noise is effectively dealt with on site (as it was with the original permission) as recommended by the appellant's noise report. This is to ensure the existing uses at Theale Depot are safeguarded.
