Adult and Community Learning Strategic Plan 2009/10- 2010/11 (Item 1.)

Resolved that the detail of the Adult and Community Learning Strategic Plan be approved subject to the following amendments:

- Page 17 – Change the key performance indicator for attendance for contracted providers from 78% to 88%;
