

Summary of Individual Executive Member Decisions taken on 29 June 2011

WBC ICT Policy Update (Item 1.)

Individual Decision No: ID2310
Portfolio Member: Councillor David Betts (Portfolio Holder for Highways, Transport (Operational) and ICT)

Resolved that the West Berkshire Council ICT Policy Update be approved with the following amendments:

Paragraph 2.2.1 - Refer to separate Member protocol;
Paragraph 5 - Bullet 2 remove 'appropriate' and bullet 4 remove 'unauthorised';
Paragraph 6.1 - Identify what to do with Member's email when they are no longer in office. Six weeks after Member is no longer in seat, out of office autoreply sent explaining who the new Member is.
