- (a) Question to be answered by the Portfolio Holder for Planning, Property, Highways, Transport submitted by Councillor Keith Woodhams:
 - "Why is this council sending police officers to carry out speed enforcement on roads in the district that do not have legal speed limits, because they are not covered by a Traffic Regulation Order (TRO) and do not have terminal signs located correctly, which could lead to a speeding fine being challenged in court wasting both police and court time?".
- (b) Question to be answered by the Portfolio Holder for Countryside, Environmental Protection, "Cleaner Greener", Culture, Customer Services submitted by Councillor Keith Woodhams:
 - "Can the Executive Member for Culture & Leisure tell me what message she has for the parents who have decided not to use the Park & Stride facility at the Thatcham Discovery Centre, because the car park surface remains muddy and spoils their children's shoes as they walk to school and these parents are continuing to park in the surrounding residential area?"
- (c) Question to be answered by the Portfolio Holder for Council Strategy & Performance, Housing, ICT, Corporate Support, Strategic Support, Legal submitted by Councillor Gwen Mason:

"I note that the housing allocations policy has recently been reviewed so that children under 10 regardless of sex are expected to share a bedroom, and children of the same sex under the age of 16 will also be expected to share a bedroom.

I am aware of families that will find this new policy impossible due to the nature of their child's disability. Will you consider making exceptions to this policy on the recommendation of medical professionals where the safety of a sibling is in doubt?"
