#### **Supporting Information**

#### 1. Background

- 1.1 The Trailer Policy at both of the Household Waste Recycling Centres (HWRCs) in Newbury and Padworth currently allow residents to dispose of household waste using trailers up to 1.8 metres (6 feet) in length. This restriction is in place to ensure the safety of site users and to ensure that the exit road is not blocked by long vehicles parking in the bays. Following some complaints from members of the public that the Trailer Policy is too restrictive, the policy has been reviewed.
- 1.2 The total length of the space, in which any combined vehicle and trailer length should fit and needs to be limited to, is 8.2m (27ft) at Newtown Road and 8.8m (29ft) at Padworth.

#### 2. Trailer Policy Review

- 2.1 The policy is in place because the vehicle and trailer needs to be able to fit into a space within the customer parking in the bays at the HWRCs and only over hang the lane closest to the bay as shown in the site plans in Appendix B. This ensures that the exit lane remains clear to traffic leaving the site.
- 2.2 Feedback from customers tells us that the current policy is not always fair as the car length should also be taken into account; if you have a short car and a long trailer the total length could still be the same.
- 2.3 To respond to feedback and complaints from customers and to meet the safety needs of the site operation it is only necessary to consider the total length of any vehicle and trailer combination rather than just the trailer length. It is therefore possible to allow a variation of trailer lengths, provided that the overall combined length of a vehicle and trailer does not exceed the length of the allowable space i.e. 8.2m at Newtown Road and 8.8m at Padworth.
- 2.4 The alternative option is to keep the current policy but this does unnecessarily restrict the use of the facilities.

#### 3. Proposed revised policy

- 3.1 The total length of any combined vehicle and trailer length needs to be limited to 8.2m (27ft) at Newtown Road, Newbury and 8.8m (29ft) at Padworth. The policy should therefore permit some larger trailers to use the sites if their total combined vehicle and trailer length does not exceed these lengths.
- 3.2 The proposed Trailer Policies for the Household Waste Recycling Centres in West Berkshire are:
  - (1) At the Newtown Road HWRC, Newbury residents are permitted to dispose of household waste using a trailer, as long as the combined vehicle and trailer length is less than 8.2m (27ft).
  - (2) At the Padworth HWRC, Padworth residents are permitted to dispose of household waste using a trailer, as long as the combined vehicle and trailer length is less than 8.8m (29ft).

#### 4. Conclusion

- 4.1 The revised policies respond to customer comments by allowing a variation of vehicle and trailer lengths but remains within the safety requirements of the sites operation.
- 4.2 There is no benefit to retaining the current policy without this revision.

#### 5. Equalities Impact Assessment Outcomes


