### **Supporting Information**

#### 1. Background

- 1.1 The Council is required to appoint representatives to a range of Outside Bodies. The bulk of these appointments were made on the 02 June 2011 following the local elections. The Council has recently received notification that Members appointed to two of these outside bodies (Thatcham Volunteer Bureau and Royal Berkshire Hospital NHS Foundation Trust Council of Governors) are no longer able to act as the Council's representatives on the organisations.
- 1.2 The Council is also required to make annual appointments to the Royal Berkshire Fire Authority and the Thames Valley Police and Crime Panel.
- 1.3 In addition there are also a number of organisations where there are vacancies for substitutes namely Hungerford Leisure Centre Joint Management Committee, Standing Conference on Archives, Tourism South East, Thatcham Vision and City Deal.
- 1.4 Appointments will be made in accordance with Appendix J to part 13 of The Constitution (Protocol for Council representatives on Outside Bodies).

#### 2. Thatcham Volunteer Bureau

2.1 The organisation provides transport for Thatcham and surrounding community residents for hospital/doctor appointments etc. Meetings take place quarterly. The Council's current trustee on the body Geoff Findlay has informed the Council that, due to ill health, he is no longer able to represent West Berkshire Council on the body.

#### 3. Royal Berkshire Hospital NHS Foundation Trust Council of Governors

- 3.1 The organisation advises on the strategic direction of the trust and is responsible for holding the Board of Directors to account. The Council's current trustee on the body Alan Law has informed the Council that, due to workload, he is no longer able to represent West Berkshire Council on the body.
- 3.2 Councillor Gordon Lundie has expressed an interest in replacing Councillor Law.

#### 4. Royal Berkshire Fire Authority

- 4.1 Members are responsible for setting the Fire and Rescue Service operating budget and determining how the service is run. Meetings of the Royal Berkshire Fire Authority take place in the evenings, on a quarterly basis, at various venues in the County. Members should note that a member appointed to this Fire Authority is expected to attend all Fire Authority meetings and to serve on at least one committee or working party.
- 4.2 Appointments to the Royal Berkshire Fire Authority are made on a proportionality basis based on the electoral roll. There were 25 members appointed in 2013/14. The Fire Authority comprises local councillors appointed by the six unitary authorities in the county: Bracknell Forest Borough Council (3 seats); Reading Borough Council (5 seats); Royal Borough of Windsor and Maidenhead (4 seats);

- Slough Borough Council (4 seats); West Berkshire Council (4 seats) and Wokingham District Council (5 seats).
- 4.3 At the Executive meeting held on 17 May 2007, it was agreed that the decision regarding Member representation on this outside body would be delegated to the Leader of the Council in consultation with the Leader of the Opposition. The appointments will be made based on the Council's proportionality rules.
- 4.4 The representatives for the 2013/14 period were Councillors Jeff Brooks, Paul Bryant, Adrian Edwards and Emma Webster.
- 4.5 The following Members have expressed an interest in being nominated to this Outside Body: Councillors Jeff Brooks, Paul Bryant, Adrian Edwards and Emma Webster.

#### 5. Thames Valley Police and Crime Panel

- 5.1 The Panel comprises 18 elected members (one from each Authority) and 2 cooptees. Appointments of elected Members to the Panel are made in accordance with each Authorities own procedures with a view ensuring that the 'balanced appointment objective' is met so far as is reasonable practicable.
- 5.2 The balanced appointment objective requires that the Panel should (when taken together):
  - (1) Represent all parts of the police area;
  - (2) Represent the political make-up of the Authorities;
  - (3) Have the skills, knowledge and experience necessary for the Panel to discharge its functions effectively.
- 5.3 A Member shall be appointed annually to the Panel to hold office matching the Municipal Year, subject to the following provisos that he/she:
  - (1) Shall cease to be a Member of the Panel if he/she ceases to be a member of:
    - (a) The Authority;
    - (b) The political group in the Authority when the appointment to hold office was made.
- 5.4 The Council's current representative on the organisation is Councillor Quentin Webb.
- 5.5 The following Members have expressed an interest in being appointed to the panel: Councillor Quentin Webb.

#### 6. Varies Appointments for Role of Substitute

6.1 There are a number of vacancies for the role of substitutes on the organisations set out in the table below:


