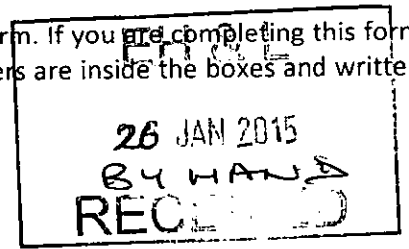

It is the view of Thames Valley Police that Premises Licence Holder, and Designated Premises Supervisor (DPS), Mr Harjit Singh Sandhu is not fit and proper to hold a position of such responsibility – a view which is based on his flagrant and persistent disregard for the Prevention of Crime & Disorder licensing objective.

Mr Sandhu has recently been convicted, by Reading Crown Court, of Perverting the Course of Justice and Handling Stolen Goods which has been further exacerbated by his apparent refusal to engage with the police to address our inevitable concerns over the impact of his offending on the licensing objectives.

With such an unwillingness to engage and with such dishonest conduct evident, we have been left with no other option than to apply for a review of the licence.

**Please provide as much information as possible to support the application** (please read guidance note 2)

On 28<sup>th</sup> July 2013, a General Report (Appendix B) was received from the Neighbourhood Sergeant, Sgt Harrison, with reference to officer's visit to the premises.

On 4<sup>th</sup> July 2013, the premises were visited by PCs Eaton & Pringle in order to view the premises CCTV data that may have recorded the identity of a known offender who was stealing alcohol from local shops. The particular time in question was approx 16:30hrs on 3<sup>rd</sup> July 2013.

Mr. Sandhu stated he was personally too busy to assist officers at that particular time. His wife was called to assist. She advised the officers that they would have to wait 24 hours in order for the data they required to be obtained from the system. She instructed the officers to return the following day.

The officers observed Mr. Sandhu texting on his mobile phone. They formed the opinion that delaying tactics were being used. Officers made arrangements to return later in the day.

PC. Eaton confirmed his suspicions to Mr. Sandhu that he was trying to obstruct police by editing out the CCTV data police required in order to conceal the sale & purchase of stolen goods on the premises.

PC Bibbin & Sgt Bone attended the premises much later that day (4/7/13). Mrs. Sandhu reconfirm she was not able to access the relevant data & an engineer had been called so officers should call back the next day.

Early on Friday 5<sup>th</sup> July 2013, PC's Eaton & Pringle arrested Mr. Sandhu on suspicion of handling stolen goods. CCTV & Mobile phones belonging to Mr & Mrs Sandhu were seized. Mr. Sandhu's phone showed an exchange of text messages between his and his wife's. The content of the text was to withhold CCTV Evidence from the police. Mrs. Sandhu later stated the CCTV was not in fact recording.

In addition, on the phone were photographs of Lanson & Aubert Champagne which had now been confirmed as being stolen items from the Co-Operative Store in Burwood on 3<sup>rd</sup> July 2013. Also photographs of Vodka which was confirmed as being stolen from Waitrose at Thatcham the same day.

On 5th July 2013, a GEN 40 report (Appendix A) was received concerning a quantity of alcohol that was stolen from Waitrose & the Co-Op Stores in Thatcham indicating that Mr. Sandhu had purchased the said alcohol at a discounted price in order to sell in his own shop knowing or believing it to have been stolen.

During interview, Mr. Sandhu at first denied having anything to do with the stolen goods but later changed his mind. He subsequently claimed full responsibility for the offences for which he has been tried at the Crown Court.

Under the Licensing Objective of Crime & Disorder, due to the seriousness of dishonesty, compounded by the fact alcohol was the main contributing factor in the case, in conjunction with the conviction & therefore mismanagement of the premises, Thames Valley Police are of the opinion Mr. Sandhu is not a fit & proper person to continue being a Premises Licence Holder, let alone the Designated Premises Supervisor for the premises.

When the result of the Crown Court case was known, Mr. Deane, Police Licensing Officer for Thames Valley Police, telephoned the premises on a couple of occasions in order to discuss the situation with Mr. Sandhu. On each occasion, his wife answered the phone who stated he was unavailable.

Having been unable to liaise personally with Mr. Sandhu, on Wednesday 26<sup>th</sup> November 2014, Mr. Deane visited the store. Again, Mr. Sandhu was not available. Mr. Deane therefore hand delivered to his wife, a letter dated 27<sup>th</sup> November 2014, addressed to Mr. Sandhu (Appendix C). Its content was to inform Mr. Sandhu police were of the opinion he was not a fit & proper person to hold a premises licence or remain as the designated premises supervisor and should no communication be received within two weeks from the date of the letter (27 Nov 14) a Premises Licence Review with West Berkshire Council would be submitted. Mrs. Sandhu opened the letter.

Prior to Christmas, Mrs. Sandhu did speak on the telephone with Mr. Deane stating they were waiting upon the result of a person check so they could put forward a person for them becoming The Designated Premises Supervisor.



Under Section 182 of the Secretary of State's Guidance for the Licensing Act 2003, Section 4:16 states the holder of a Personal Licence is under a duty to notify any convictions for a relevant offence (in this instance Receiving Stolen Goods) to the Licensing Authority. In this case it is Slough Borough Council. To date 21<sup>st</sup> January 2015, no such notification has been received by them.

To date, 23<sup>rd</sup> January 2015, Police believe they have been more than patient with Mr. Sandhu in attempting to address the situation without the need to resort to a Premise Licensing Review. Telephone calls, a personal visit and a letter have all failed to resolve the situation.

With such dishonest and blatant disregard for the law and the licensing objectives, we are of the view that revocation of this premises licence is appropriate under the circumstances.

In preparing this application, we have considered the other steps that would be available to the sub-committee, but which we have precluded from our recommendations for the following reasons:

Removal of the DPS: - the premises is family run, so removing Mr Sandhu as DPS does not change the fact that he will remain in overall control of the business and therefore is unlikely to result in the alleviation of our concerns.

Removal of a Licensable Activity from the scope of the licence: the premises is licensed only for the sale of alcohol, so this option is tantamount to a revocation.

Modification of conditions: there are no conditions that would address our concerns and in any case, Mr Sandhu's behaviour has done nothing to satisfy us that any such conditions would be complied with.

Suspension of the licence for up to 3 months: unless it were to facilitate the transferring of the licence (and changing the DPS) to someone more responsible, with the demonstrable assurance that Mr Sandhu would no longer have any control of the business, suspension would seem unlikely to achieve any significant benefit.

**Nature of Incident - what happened?**  
 A well known shoplifter from the Thatcham area has stolen items from Co-op and Waitrose and then proceeded to sell them to Crown Mead Stores. Knowing the items were stolen the DPS has bought these at a reduced price from the male and then proceeded to try and sell them in his shop.

**Business Response - what did they do? (How do they react to the police and their performance)?**  
 When police got an idea this was happening, they attended the shop to ask for CCTV. The DPS (Harjit SANDHU) had deleted the CCTV and was arrested along with [REDACTED]. When interviewed Harjit initially tried to blame [REDACTED] for the entire thing saying she was the one that bought the stolen goods and he didn't really know about it. However he changed his mind and on a second interview fully admitted the offence of handling stolen goods and buying alcohol and meat. He claimed he ate the meat but tried to sell the vodka and champagne in the shop to make some money.

**CROWN MEAD STORES, THATCHAM**

What follows is a report on recent criminal and suspicious activities by the proprietors of the above premise, namely –

SANDHU – Harjit Singh,  
SANDHU – Navdeep,

On Thursday 4<sup>th</sup> of July 2013, at about 1510hrs officers – PC EATON & PC PRINGLE, attended Crown Mead Store off license and requested to view CCTV at the premise for a suspicious male. This was as a result of information received that a well known offender was stealing high priced alcohol from local shops and selling them to the owner of Crown Mead Stores at a hugely discounted price. PC EATON asked to view the CCTV for a suspect for an offence which had occurred nearby. These officers were obstructed firstly by Mr SANDHU who stated he was too busy but called his wife to assist. Mrs SANDHU took several minutes to appear and when she did she informed officers that there was a need to wait 24hrs for footage to be saved on the system. Mrs SANDHU instructed officer there was a need to come back the following day to see the footage they required. While this was going on officers were aware that Mr SANDHU was texting on his mobile phone and generally got the impression they had been fobbed off by both Mr & Mrs SANDHU. PCs EATON & PRINGLE subsequently requested that I make arrangements to for officers to re attend the premise later that day as they were specifically interested in footage from about 1630hrs on 3<sup>rd</sup> July. Before officers attended I received further contact from PC EATON confirming his suspicions that the SANDHUs were intending to edit the CCTV to frustrate the police investigation into the sale/purchase of stolen goods on the premise. PC BIBBINS and SGT BONE re attended this premise much later in the evening but were told by Mrs SANDHU that she was not able to access the relevant footage and that an engineer had been called so officers should re attend the following day. I subsequently informed PCs EATON & PRINGLE of this.

Early on Friday 5<sup>th</sup> July 2013, PCs EATON & PRINGLE attended Crown Mead Stores and were taken to the SANDHU's home address nearby where they arrested Mr SANDHU on suspicion of handling stolen goods. The CCTV system and mobile phones belonging to them were also seized. Subsequent examination of Mr SANDHU's phone showed an exchange of text messages between Mr and Mrs SANDHU where they were discussing withholding CCTV evidence from the police. Photographs were also viewed by PC EATON on this phone. These photos showed Lanson & Aubert Champagne which has now been confirmed as being stolen from the Co-op Burdwood on the afternoon of 3<sup>rd</sup> July 2013, bottles of Vodka now confirmed as stolen from Waitrose, Thatcham the same day, and two photos of large quantities of meat from the co-op also believed to have been stolen. The photos of the meat were dated 01/07/13 and 04/07/13 respectively. Mr. Sandhu was subsequently interviewed about the allegations and initially Mr SANDHU blamed his wife for any wrong doing, claiming not to have been involved in any way with the handling of stolen goods. This was retracted a short time later after legal consultation. Mr SANDHU subsequently claimed full responsibility for buying stolen meat and alcohol from a male known to him as ??????.

On 16/07/13 Mr SANDHU were charged with Perverting the Course of Justice in relation to the obstruction of police when trying to obtain relevant CCTV footage. Mr SANDHU was also charged with another offence..

There have been concerns about the lack of responsible retailing from this premise for some time with reports of selling to under age persons – both ??????? and alcohol – being prevalent over time. Given that we now have confirmation that the DPS Harjit SANDHU is actively involved in criminal activity I feel this should proceed to full review of the license. Mr. Sandhu is the Premises Licence Holder & Designated Premises Supervisor. As such as requesting removal of DPS is unlikely to provide a satisfactory proprietor.

**Reference to Premises Licence Number 017703.**

I'm writing in response to your recent Reading Crown Court appearance on 24<sup>th</sup> October 2014 when it was proved you were guilty of Dishonesty Offences. You received a suspended imprisonment sentence for 8 months wholly suspended for 24 months as well as costs and unpaid work.

The offences are relevant convictions under the Theft Act and The Licensing Act. Due to these offences, Thames Valley Police are of the opinion you are therefore not a fit and proper person to retain the Premises Licence for Crown Mead Stores or indeed remain the Designated Premises Supervisor.

I'm therefore notifying you if I do not receive any form of communication from you within two weeks from the date of this letter, I shall instigate a Premises Licence Review with West Berks Council.



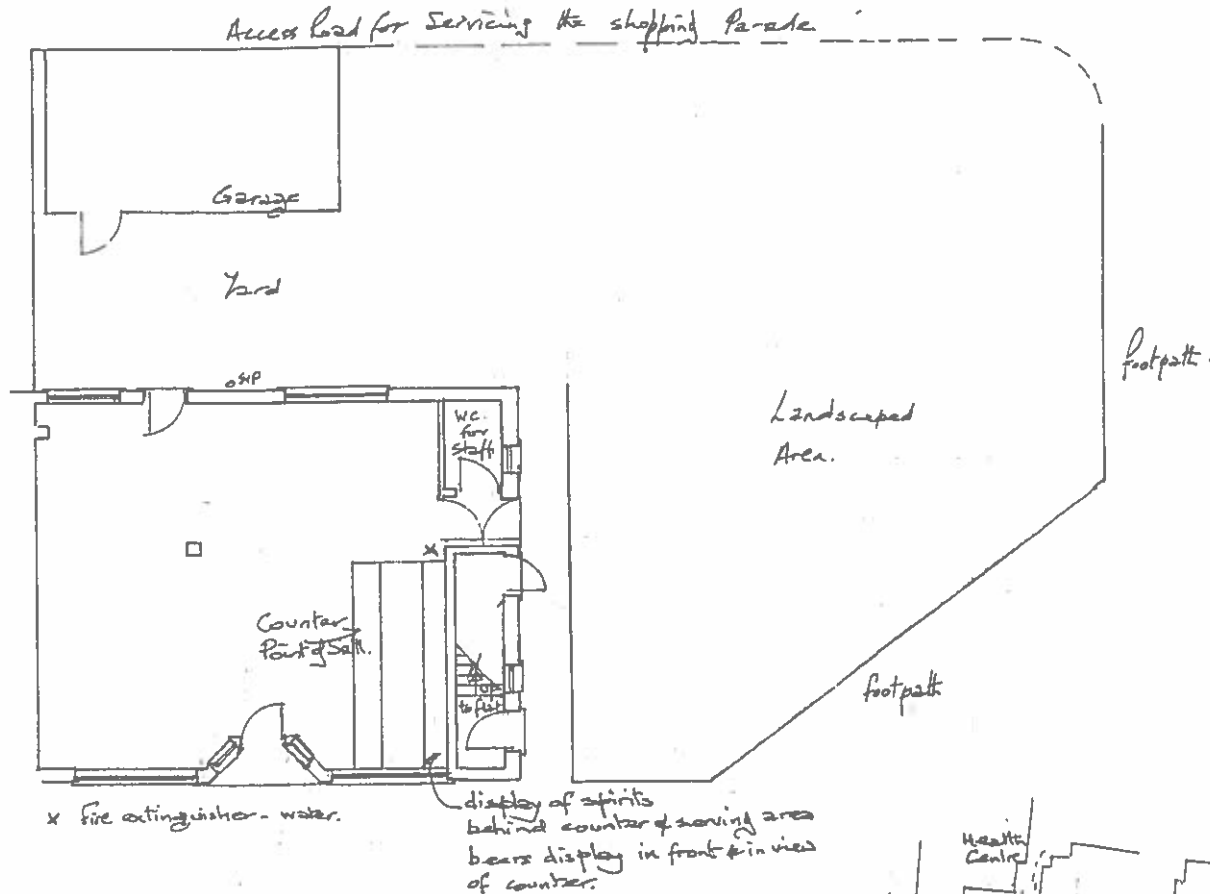

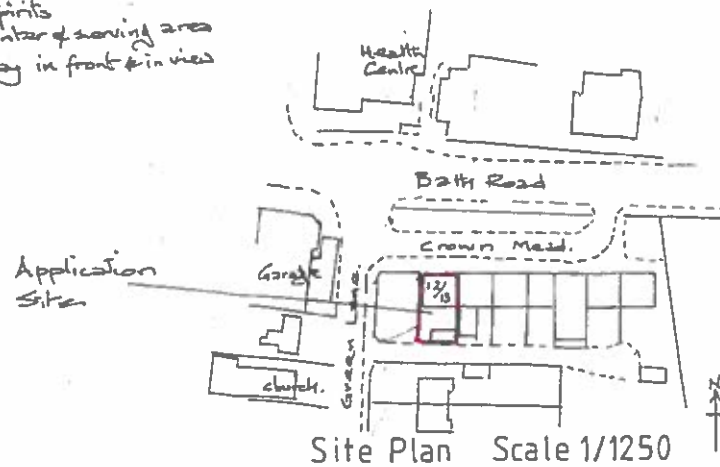
