## 6. Introduction/Background

- 6.1 The Standing Advisory Council on Religious Education (SACRE) was established in accordance with Section 390 of the Education Act 1996 by West Berkshire District Council acting as the Local Education Authority.
- 6.2 The SACRE was established to set the RE syllabus, advise the Local Authority on matters connected with religious worship and advise on methods of teaching, the choice of materials used and the provision of training for teachers.

## 7. Supporting Information

### Nominations for membership of the West Berkshire SACRE

- 7.1 The Local Authority is responsible for appointing members to each of these four groups. This is usually achieved by seeking nominations from each area.

The standing Advisory Council on Religious Education comprises four groups each with a single vote to use when voting is necessary.

The four groups are:

Group A: Representatives of Christian denominations other than the Church of England and of other religions	Group B: Church of England representatives
Group C: Up to 6 Education Union representatives from the following Unions, with no more than 3 from any one union: NUT, NAS/UWT, ATL, PAT, NAHT, SHA	Group D Representatives of the local authority

## 9. Proposals

- 9.1 A nomination has been received for:
- 9.2 Maria Pratico a former member of WB SACRE, first appointed in 2014. If appointed, Maria Pratico would represent Group B (Church of England representatives) on the West Berkshire SACRE.
- 9.3 Rabbi Zvi Solomons, a former member of WB SACRE. If appointed, Rabbi Solomons would represent Group A (Representatives of Christian denominations other than the Church of England and of other religions).
- 9.4 Rachel Manley, Headteacher, Yattendon C of E Primary School was nominated by Keith Harvey to replace him as LA Advisor. Rachel Manley was the RE lead at St Nicolas C of E Junior School where Keith Harvey is Headteacher.

- 9.5 David Rees was nominated by Alison Harris to replace her as LA Advisor. David Rees is a highly experienced advisor to SACREs with qualifications and teaching experience relevant to RE.
- 8.6 All nominations have been supported by the Local Stakeholders as set out in the consultation responses. Following consultation no objections were received to this nomination.
