#### Report

#### 1. Introduction

After discussion with our neighbouring authorities a draft calendar of term and holiday dates for 2025/65 was prepared. As we have aligned dates with our neighbouring authorities it is not expected that there will be any cross-border difficulties.

#### 2. Consultation

The consultation ran from 8 January 2024 to 16 February 2024. The consultation was published on the West Berkshire Council consultation finder section of the website making it publicly available for responses. The consultation was also emailed to the following stakeholders:

- All Head teachers (including academies)
- All School offices (including academies)
- Newbury College
- Parish Councils

West Berkshire provides the term and holiday dates framework for maintained schools.

The framework covers 191 days, which is comprised of 190 "pupil days" and one common training day in September. Schools must set four training days from outside of the "pupil days".

The Council recommends that schools consider aligning term dates with other schools in the area, for example, secondary schools with primary schools, in recognition of families with children at different schools.

#### 3. Responses

15 responses were received in total of these Agree = 4 Disagree = 11

- 9 respondents submitted comments for consideration.
- Summer term half term could be a week later? Very imbalanced
- disagree with some of the suggested INSET days primarily Friday 2nd jan
- As a working parent it is difficult to find child care in the holidays . Why don't you have more half term week holidays instead of the ridiculously long summer break. It's an absolute nightmare.
- Scrap the 6 week summer break
- No good reason to change
- All seems sensible and well planned.
- Term dates are planned accordingly, prefer to match Oxfordshire and Hampshire.
- It is really frustrating when all possible INSET Days fall in the autumn term. This gives school leaders no chance to have a decent amount of time with staff to work on issues / developments that might come up within the school year. There is in effect only 1 day that is negotiable - that one would either give an INSET on Dec 19th or July 22nd...neither is particularly good for focused work.
- I don't understand why odd days have to be added onto half terms. It would be better to finish on a Friday so that the whole week is completed. Going back on a Monday after Christmas doesn't work well as children are tired after the Christmas breaks due to late nights over Christmas and New Year.
- Why are you suggesting having an INSET day on the 2nd April when this is in the middle of the Easter break. Would it make more sense to break up on the 1st April 2026 and then have the INSET. The second week of the holiday could then be moved further into April?
- Return in September is to late and the Christmas Break is less than two weeks for staff and students

#### 4. Neighbouring Local Authorities

Proposed term dates were received from Hampshire, Reading and Oxfordshire Local Authorities. The dates chosen also match with their neighbouring authorities making for a much wider community.

A comparison table is available in Appendix C. Our neighbouring authorities all set 195 school days which includes the training days which is why there are some variances, but all other term dates are broadly in line (given that the number of days set varies by LA).

#### 5. Consideration of Comments

The comments were considered by Rose Carberry on 20 February 2024. Some of the comments refer to length of the school year and number of holidays these are beyond West Berkshire Council decision making as the Government set out the statutory duties regarding number of school days.

Regarding the comments requesting changing dates to better suit childcare/working parents or personal views, the dates have been chosen to match neighbouring authorities and thus alleviate difficulties for families and staff with children at different schools.

The comments regarding inset days are noted, however, schools make their own decisions regarding the recommended inset days and often choose alternative dates or twilight sessions.

On balance, as the dates chosen match all our immediate neighbouring authorities and also their neighbouring authorities it makes sense to agree with the majority.

#### 6. Recommendation

As a result of the consultation it is recommended that:


