With the exception of staff still undergoing training, all staff will be trained in those aspects of their job relating to the prevention of crime and disorder, the prevention of public nuisance, and will be aware of those aspects of the Health and Safety at Work etc. Act 1974 which relate to their role within the business

**b) The prevention of crime and disorder**

We will not employ any staff unless they have been properly trained in those aspects of their job which may have an impact on crime and disorder. The only exception will be for staff still undergoing training, providing that they are closely supervised when serving customers

**c) Public safety**

The public Safety side of our business is governed by the Health and Safety at Work etc. Act 1974 and in general we will not be doing anything extra to satisfy the requirements of the Licensing act 2003. We will take care not to leave dangerous items such as dinner knives and glass containers within the reach of customers at night, when some of them may have consumed alcohol elsewhere before entering the premises

**d) The prevention of public nuisance**

The sale of heated food on our premises does not cause any noise problem in itself.

We will make sure that our customer door does not bang shut, and that any alert used to signal that the door has been left open does not create a noise problem for neighbours.

Where customers persist in hanging around outside in groups, we will advise them that elderly people in particular often feel intimidated by this. If it is safe to do so, we will advise them politely to disperse

The sale of heated food has no direct relevance to protecting children from harm and we will discharge our responsibilities under the Licensing Act simply by being good citizens.
