

Annex 3 – Conditions attached by Thames Valley Police 23/03/2010

1. The premises will not be open to customers who personally attend the premises between the hours of 02:00 hrs and 05:00 hrs Monday to Sunday inclusive.
2. Between the hours of 02:00hrs till 05:00hrs Monday to Sunday inclusive any entry or exit doors and any shutters or grilles shall be secured preventing customers from gaining entry. (Providing Fire Regulations are not breached or Emergency egress routes are not impeded).
3. Between the hours of 02:00hrs till 05:00hrs Monday to Sunday inclusive, only telephone or email orders for a home delivery service shall be accepted.
4. The Premises Licence Holder shall ensure the Digital CCTV System installed at the premises shall be maintained in good efficient working order save when it breaks down and shall be repaired as soon as possible. All cameras shall continually record whilst the premises are open to the public and the recordings shall be kept available for a minimum of 31 days with time and date stamping. Data recordings shall be made immediately available to an authorised officer of West Berkshire Council or a Thames Valley Police Officer, together with facilities for viewing upon request. Recorded images shall be of such a quality as to be able to identify the recorded person.
