Many comments suggested that the Town Centre's offering would be diminished by the reduction in funding for this service. There were no other issues raised but the overwhelming view was that the service was both well used and valued.

However, given that the public health grant is ring fenced for a further two years it is suggested that the Council continue to fund this service until this position changes.
