Key issues raised:	 The proposal will result in an unacceptable level of cleanliness, reducing the quality of life in the district. Litter will increase and litter bins will overflow, leading to an increase in vermin, health hazards and an unsightly, dirty district which will deter visitors and impact on local business. Reduced weed spraying will create damage to the highways as weeds grow in the fabric of the highway and make it more 						
	 difficult to properly cleanse the streets. Reduced street cleansing will result in more detritus being washed down into the drainage system creating more blockages and putting more pressure on the gully cleansing service. The proposal will lead to an increase in complaints which is counter-productive as it will waste valuable officer time.

Suggestions for reducing the impact on service users:	Suggestion	Council response					
	Provide physically larger litter bins in high pedestrian traffic areas and more litter bins in areas where there are few.	Where frequencies of litter picking and/or street cleansing are to be reduced the provision and specification of litter bins within that area will also be considered.					
	Provide more education to encourage the public to dispose of litter carefully.	The Council intends to launch an education programme in 2016/17 which will include raising public awareness of the need to dispose of rubbish and litter responsibly.

Parish Councils raise funds through the Council tax for contractors or to fund a Community support officer with the power to raise fixed penalty notices. 					
Officer conclusion as a result of the responses:	The key concerns raised were that the proposal will result in an unacceptable level of cleanliness, reducing the quality of life in the district. Concern that litter will increase, litter bins will overflow, leading to an increase in vermin, health hazards and an unsightly, dirty district which will deter visitors and impact on local business. The exercise also raised the issue that the proposal could put more pressure on the Highways Service, which is also subject to a budget reduction consultation; specifically in gully emptying and highway maintenance.					
Officer recommendation as a result of responses:	Feedback has not uncovered any issues which would prevent the council from proceeding with this proposal. It's therefore recommended to implement this proposal with no changes.
