5. Other options considered

5.1 No other options were considered as this was a review and refresh of the Newbury Town Design Statement originally adopted in 2005.

6. Introduction/Background

- 6.1 The Newbury Town Design Statement is a document describing the qualities and characteristics that local people value in the town and its surroundings. It sets out clear and simple guidance for the design of all development in the town. It cannot be used to stop new development, but it can be used to influence developers and the local planning authority, and to ensure that new buildings respect and reflect local character.
- 6.2 Such design statements are intended to influence the operation of the statutory planning system and this has worked well in West Berkshire in the past. The Council has actively encouraged the production of design statements and since 2001 seventeen Design Statements have been adopted by the Council.
- 6.3 Since June 2008 design statements achieve recognition through the community planning process rather than the statutory planning process, as previously. However, it does not mean that they are seen as any less important.
- 6.4 To ensure that design statements produced in this way are still accorded weight in the planning process, for example, by planning inspectors at appeals, it remains particularly important to show that they:
 - have been produced in consultation with the local community and stakeholders, including statutory consultees;

- conform with relevant development plan policies; and
- have been adopted by the Council.
- 6.5 The following procedures are therefore being adopted by community groups in West Berkshire when preparing design statements:

Stage 1

Production of draft design statement by the design statement group with the involvement of a wide cross-section of the local community;

Stage 2

Officer agreement to final version of draft design statement;

Stage 3

Six week 'formal' consultation period where the design statement group consults with the local community and West Berkshire Council consult with relevant stakeholders & statutory consultees;

Stage 4

Amendments to the design statement made as appropriate;

Stage 5

Design statement group presents final design statement to the Council for adoption as an Individual Executive Member decision.

6.6 The review of the Newbury Town Design Statement has been carried out in accordance with this procedure.

7. Supporting Information

- 7.1 The Newbury Town Design Statement was originally adopted by West Berkshire Council in 2005, but it was decided by Newbury Town Council that a refresh should be undertaken and in 2016 a Working Group was set up to review the design statement. The review has resulted in updated text and graphics, as appropriate, to reflect the changes which have taken place within the town since 2005. It is not considered that this review has fundamentally changed the original design statement but the changes do provide a more up to date document. A six week period of public consultation was carried out in January 2017 prior to the submission of a draft to West Berkshire Council in June 2017.
- 7.2 Formal consultation on the draft design statement was undertaken by West Berkshire Council for a period of six weeks from 6th October to 17th November 2017. Officers consulted directly with all active consultees on the Local Plan consultation database, which includes statutory agencies, national interest groups, adjacent parish councils, local interest groups and local developers (or their agents). In addition, the draft document was made available on the Council's website, as well as the Town Council website.
- 7.3 Overall, 10 formal consultation representations to the draft document were received. The representations and recommended Council responses, along with the Working Group responses are all set out in Appendix B.

7.4 On the whole the consultation representations were positive and constructive. The Working Group has made amendments to the draft document in response to the consultation and as set out in Appendix B. A final version of the Newbury Town Design Statement (2018) is attached as Appendix C.

8. Conclusion

8.1 If the refreshed Newbury Town Design Statement is endorsed and adopted by West Berkshire Council it will replace the original 2005 design statement, provide detailed context for existing policies in the West Berkshire Local Plan and, where appropriate, will be used as a material consideration in the determination of planning applications.
