Application for a Premises Licence
St Bartholomews School, Andover Road, Newbury

Environmental Health (Pollution) have considered this application for a premise licence and would make the following comments:

The school is located within a residential area with properties in close proximity on all boundaries. With the recent redevelopment of the school there are school buildings on the majority of the site, with one grassed area adjoining Fifth Road which is shown as two football pitches on the submitted plans, and an additional sports area adjacent to Andover Road. There are then various small landscaped areas around the new building externally.

The application is for all regulated activities Sunday – Thursday 07:00-22:00, Friday – Saturday 07:00-00:00, except for Live Music which details Mon – Thursday 07:00-22:00 and Friday - Sundays 07:00-00:00, with a later finish on Sunday compared to other regulated entertainment.. The activities Plays, Boxing & Wrestling, Live Music, Recorded Music , Performance of Dance, Anything of a similar description, Provision for making music, Provision of facilities for dancing, Provision of facilities for entertainment of a similar description and Late Night Refreshment have all been put forward as being both Outdoor and Indoor functions.

Considering the activities and hours applied for there is concern that noise from outdoor regulated activities, in particular live and recorded music , could occur up until 22:00 hours Sunday – Thursday, and up to midnight Friday, Saturday (and Sunday for live music). Due to the close proximity of the residential properties it is considered that there is the potential for disturbance from regulated activities outdoors.

Under Section P d) it is stated that it is not anticipated that public nuisance would be caused by any events held at the school. There are no conditions proposed to monitor for possible noise nuisance from an event, or conditions relating to management of an event. The response suggests that the possibility of public nuisance has not been considered in full.
