Opposition Spokesperson:

Councillor Alan Macro raised the following matters:

"The stated aim of this paper is to "ensure that staff are clear regarding the process of requesting funding for residential and nursing placements. Our complaints team suggested that our process for funding requests is made more easily understandable..." However. I find the proposals difficult to understand. In particular:

- In section 2.8 it says that "a person can also choose to be placed in a setting which is outside of the LA's area and the LA must still arrange for this" whereas in section 3.3 it says "WBC will prioritise use of its own in-house services (residential and nursing) in order to manage resources effectively". Without any qualification, these two statements seem potentially contradictory. (see amendment 3)
- In section 5.2 it says "in cases where a placement or care provision is more than the cost that WBC would usually pay for residential or nursing care then the options method noted above needs to be in place prior to a case being presented to GPF". It is not clear which options are being referred to. (see amendment 4)
- Section 5.3 would be clearer if it referred specifically to section 6. (see amendment 5)
- Section 6 should refer to the policy on third party top ups (see amendment 6)

The flowchart in appendix 1 would be more useful if it included the decisions that have to be made." (see amendment 7)

Local Stakeholders:

A local resident Paula Saunderson (a member of an Independent group of At Home Dementia Carers) who raised the following queries:

1. In October 2020 the State Pension Age for Men & Women raises to 66 so looking at provision for the over 65s would seem to need changing to over 66, especially with Income discussions being a key part of the ASC Service. It would be much simpler for us as end users if your policies were aligned with new

	 SPA. Is this something you would consider please? (see amendments 1 and 2) 2. It is difficult to establish where and how the policy is changing or being clarified, and whether this means terms and conditions are less or more advantageous than previous policy? The accompanying form (the
	usual one) in the Agenda Pack just states there were complaints about confusion and not which areas were confusing. Would you be able either highlight the changes in the new document or provide a summary of the clarifications, please? (Copies of the original and revised documents provided to Ms Saunderson)
