Dear Sirs,

It has come to our notice that a Northcroft resident has made an application to have the premises licence removed from the annual Real Ale Festival, on the grounds that the noise levels constitute a public nuisance and encourage criminal behaviour. As we live in the locality we would like to comment on the application.

We have no experience or evidence of criminal behaviour resulting from the Festival, though would have thought that this would be more likely associated with the amount of alcohol on sale than the noise itself. However, the noise levels have increased significantly over the years of the Festival, and are due to the music being performed at very high levels of amplification. The levels are now such that they are disruptive even inside our house, as well as in our garden. Subjectively, they are more of a nuisance than, for instance, the recent Michaelmas Fair, partly due to the duration of the disturbance. For those residents directly adjacent to the site they must be considerably more of a nuisance.

When the Festival first started the noise levels were unproblematic, and the overall feel of the Festival was of a community event in keeping with its location. But the organisers seem to have felt that each year the Festival needs to be bigger than the year before, with more and louder music. Their timekeeping also seems poor — this year they appeared to overrun by a couple of hours into the night, if their website was to be believed.

I would like to suggest that the Council encourages the organisers to decide whether they wish to continue to mount what now feels more like a pop festival than a beer festival, and if so to find a site more appropriate to this. Or whether to return to the more community-based event of the earlier years, in which case Northcroft would be a perfectly fine venue with the advantages it brings for access and local trade.

I live within 400m of Northcroft Park in Craven Road and the noise from the event was louder than ever before and went on at a loud volume for longer than usual. However my objection to the event comes mainly from the number of adverse comments I saw at the time on social media from addresses through Newbury and beyond: New Road Greenham, Manor Park Cold Ash, Donnington & my own ward - Wash Common - among them.

I have attended the event in the past and would not want it to be banned. However the applicant is in my view right to ask for tighter control over the event by the organisers and by this Authority at the time. Like many events that are popular, it is in danger of being a victim of its own success.

There is no need for music to play at such a loud volume. There is need for more toilets on site to deal with the numbers.
