# **Executive Summary and Report**

#### 1.0 Introduction

1.1 The Council adopted a new Constitution in 2001 and since that time has carried out a number of reviews to ensure that its decision making processes are as effective and efficient as possible. Over the past year a number of issues have arisen and the Leader of the Council has asked that these issues be addressed by the Committee and forwarded to Council for approval.

#### 2.0 Executive Rules of Procedure – Part 5 – Members Questions

2.1 Paragraph 5.11.2 deals with Members' Written Questions. At the present time Members questions are included as the fifth item on the agenda (Paragraph 5.6.1 refers) and follows questions received from the Public. The proceeding items are:

Apologies
Minutes
Declarations of Interest
Public Questions
Members Questions

- In order to improve the efficiency of meetings of the Executive it is proposed to amend Paragraph 5.6.1 to provide for Members Questions to included as the last item on Executive agendas prior to Part II matters. This mirrors the Rules of Procedure for Council (Paragraph 4.3.2 refers).
- 2.3 In addition to the proposal set out in Paragraph 2.2 above, it is also proposed that each Political Group on the Council be limited to five guestions per agenda.

### 3.0 Regulatory and Other Committees Rules of Procedure – Referencing Up

- 3.1 Paragraphs 7.1.1, 7.3.4 and 7.3.5 all deal with Referencing Up and Exceptions to Referencing Up. The Committee will be aware that on 14 December 2004 the Council agreed to move from a four area based Planning Sub-Committee structure to an Eastern and Western Area Planning Committee structure. These changes involved the two Planning Committees meeting every three weeks replacing the previous 6 weekly schedule operated under the four area based Planning structure. Modifications to the Planning Protocol governing the referencing up by Members of Officer delegated decisions to Planning Committees were also made.
- 3.2 The purpose of moving to this new structure and modifying the Planning Protocol was to ensure that planning decisions were made much quicker but still with the degree of accountability and public involvement associated with the four area based Sub-Committees.
- 3.3 Since introducing the new planning structures the performance of the Planning Service has been improved significantly and public involvement in the planning decision making process has been maintained.
- In order to improve the efficiency and accountability of the planning decision making process further it is now proposed to remove the "Referencing Up" provisions as set out in Paragraphs 7.1.1, 7.3.4 and

7.3.5. This will effectively mean that Area Committees will be expected to determine all planning applications coming before them.
