## **Supporting Information**

#### **Background**

- 1.1 Chris Marriage was appointed as the Council's representative on the Thames Valley Group Valuation Tribunal Service by Individual Decision (ID0744) on 26 March 2004. However when this decision was made it was not realised that under a change to the Valuation and Community Charge Tribunals Regulation 1989 there was now a need for West Berkshire Council to appoint 4 members. This therefore left three vacancies.
- 1.2 The Tribunals are quasi-judicial bodies and the members do not represent appointing bodies when fulfilling that function. As stated in the letter from Murray Campbell, Clerk to the Tribunals and Head of Administration for the Thames Valley Group, attached as Appendix A, the President strongly recommends that the appointing body appoint existing members of other tribunals in the Thames Valley Group when vacancies arise.
- 1.3 The President therefore recommends that the other three vacancies are filled by the following members:
  - 1) Mr H.A John
  - 2) Mr J.P Seddon
  - 3) Mr H Davis
- 1.4 Members are appointed for six years and must retire on reaching the upper age bar of 72.
