#### 1. Background

- 1.1 Pressure to construct the Monkey Marsh footbridge in place of the existing at grade railway crossing by Bridleway 18, has increased due to the development of the adjacent former MoD site in Thatcham for residential use
- 1.2 A number of designs and methods of procurement were considered before it was decided to proceed on the basis of a negotiated, target cost contract using a Principal Contractor selected by a Panel of Members. It was determined that this procedure would not only offer best value but would expedite delivery of the project.
- 1.3 A Panel comprising Councillors Sally Hannon, Brian Bedwell and Owen Jeffery convened on 28<sup>th</sup> July 2004 received presentations from two contractors, a third having withdrawn at the last minute, and were unanimous in recommending the appointment of Dyer and Butler Ltd.
