1. Background

- 1.1 It is proposed to construct a school bus parking area on the un-named road (known locally as Bradfield Road) that links The Green and the A340 Pangbourne Road for the number of buses that deliver and collect pupils attending Theale Green School. It is proposed that buses will approach the bus parking area from the A340 Pangbourne Road and exit via The Green.
- 1.2 Given the swept path of a bus it is necessary to prevent vehicles parking on The Green at its junction with the un-named road and Deadmans Lane so that buses can safely negotiate the junction. Statutory consultation on the proposal to introduce 'No waiting at any time' restrictions at the junction was undertaken on 11 November 2004.

2. Responses Received

- 2.1 At the end of the statutory consultation period responses had been received from Councillor Alan Macro and Theale Parish Council.
- 2.2 Theale Parish Council requested that the proposed restriction should only operate during school term times and during the school opening hours. Councillor Macro suggested that the restriction should be extended on the un-named road to prevent parked vehicles obstructing school buses when they exit the bus parking area.

3. Officer Comments

- 3.1 Whilst the bus parking area will mainly be used at the beginning and end of the school day, it may also be used in the evenings, at weekends and during the school holidays. Revising the restriction may lead to buses being obstructed by parked vehicles. It is also considered that restrictions which prevent parking at all times at this unusual junction, which features two roads in very close proximity, is desirable from a road safety perspective.
- 3.2 The extent of the proposed restrictions will enable buses to manoeuvre through the junction safely and keep sightlines clear for traffic exiting Deadmans Lane and the un-named road. The design and location of the bus parking area is such that buses should not encounter difficulties when leaving it. Consequently it is not considered necessary to extend the restrictions on the un-named road, which would require the re-advertisement of the traffic order and hence delay implementation. However, if buses were to experience difficulties it would be possible for additional restrictions to be implemented at a later date. This solution enables the scheme to go ahead without delay.

4. Recommendations

4.1 It is recommended that the proposed restrictions be introduced as advertised and that the respondents be informed accordingly.
