1 Background

- 1.1 As part of the Speed Limit Review held during October 2006, the Speed Limit Task Group considered and recommended a request to introduce a 20mph zone on the High Street, between its junctions with Church Lane and the un-named road linking High Street to the A4.
- 1.2 It was also considered appropriate to include the residential housing estate to the eastern end of the village as this area is extensively traffic calmed by a series of raised tables.
- 1.3 The Speed Limit Task Group recommendations were formally approved by Individual Decision on 21st December 2006. The proposed 20mph speed limit was then advertised during August 2007.

2 Results of statutory consultation

- 2.1 At the close of the statutory advertisement and consultation period two responses had been received. One was from The Police supporting the proposal and one from a resident of Woodfield Way objecting to the proposal.
- 2.2 The Police supported the proposal as there are traffic calming measures which would make the 20mph speed limit self enforcing.
- 2.3 The objection to the 20mph zone was made on the grounds that the measures already in place were adequate to control vehicular speed in that area. It states that cars already are unable to negotiate these measures unless they travel at very low speeds and statutory reduction of the speed limit is not necessary.

3 Conclusion

3.1 It would make sense to include the residential area within the 20mph speed limit zone due to the character of the estate, the possibility of children using the roads and given that traffic calming features already exist.

4 Recommendations

4.1 It is recommended that the proposed 20mph zone be introduced as advertised and that the respondents to the statutory consultation be informed accordingly.

1. Background

1.1 To recommend that a Saturday parking charge is introduced in the car park at the Football Club, Faraday Road, Newbury.

2. Factors for Consideration

2.1 The car parks in Newbury have four groupings with a unique tariff structure for each group.

(a) The first group comprises the Kennet Centre and Northbrook multi-storey car parks.

(b) The second group comprises Pelican Lane, Parkway, West Street, 8 Bells, Market Street and Central and this group offers both short-stay and long stay parking within a graduated tariff structure.

(c) The third group comprises Jack Street, Northcroft Lane, Northbrook Place, the Wharf, the Mall Cheap Street and Bear Lane. The tariff structure for this group is geared to short-term shopper parking, with parking over three hours at a higher price.

(d) The fourth group comprises those car parks that are slightly out of the Town Centre and includes Northcroft Lane West; Newbury Football Club (parking charges currently apply on weekdays only); and the Council's staff car park in Market Street (available only on Saturdays).

2.2 The car park at the Newbury Football Club lies at the end of Faraday Road and offers 70 parking spaces. It falls within the fourth group of car parks set out in 2.1(d) above and its' out-of-Town location is reflected in the modest scale of charges which are shown in Table A below. The low parking charges shown in Table A should be compared to the 70p per hour charge that is uniformly applied to all the car parks that fall within the first three groups of Town Centre car parks.

- 2.3 The Council owns the site, but under the arrangements concluded with the former holders of the lease for the football club site, parking charges were operated by the Council on weekdays only and not on a Saturday. Instead, spectators attending Saturday matches could park there and pay a small parking fee, the value of which was then deducted from the match admission fee. This arrangement was administered solely by the then football club organisers.
- 2.4 The Council's Transitional Parking Strategy has recognised the importance of putting customers first during the impending period of Town Centre development. Through the existing tariff structures, the Council provides for a range of customer requirements ranging from very short-term parking to all-day budget parking. However, it is important to ensure that customers in all of the car parks receive equal treatment and this includes the requirement to pay for their parking.
- 2.5 The former Newbury Town Football Club that used the Faraday Road ground and the car park is now defunct. The current leaseholders no longer have the match-day parking arrangement and consequently parking in this car park is free to the public on Saturdays. This is an anomaly in Newbury as all of the Council's other pay to park car parks in the Town have a Saturday charge. The exception is the Bayer car park, which is leased by the Council for use on Saturdays only, and offers free parking.
- 2.6 It is considered that a Saturday parking charge should immediately be introduced at the Football Club car park following the necessary statutory advertisement. The charge should be same as the weekday charge in Table A. This will then ensure that all the car parks that fall within Group 4 (see 2.1 (d)) of the Council's pay to park car parks are consistent in both their charges and the days of charging.

3. Financial Implications

- 3.1 The cost of advertising the Parking Order and amending the tariff board will be about £1,000.
- 3.2 It is considered that there will be a modest financial impact. Income, in a full year, is expected to increase by some £1,500.

4. Conclusions

- 4.1 All of Newbury's car parks will play an important role in delivering the Council's Transitional Parking Strategy. While the use of all parking resources must be encouraged and optimised during the period of Town Centre re-development it is equally important that the Council's tariff structure for each group of car parks is consistently applied.
- 4.2 There is currently no Saturday charge at the Football Club car park in Faraday Road, Newbury. This is an anomaly as all of the Council's other pay to park car parks in the Town levy a Saturday parking charge. It is proposed to correct this anomaly by applying the existing weekday charge at this car park on Saturdays. This would take immediate effect following the necessary statutory advertisement.

5. Recommendations

- 5.1 That a Saturday tariff structure be implemented for the Football Club car park as shown in Table A, in Section 2.2 of this report.
- 5.2 That the relevant Parking Order be amended and advertised as necessary.

The Football Club has charges all week except Saturday and this is inconsistent with the Council's other pay to park car parks.

While you estimate that the payback is 8 months against the cost of signs, what additional enforcement will be needed? Will this impact existing enforcement ability as the Football Club is away from the centre, thus there might be lost revenue elsewhere.

Generally, I am not sure if this will be seen as just another tax on the motorist, with no visible benefit at a time of considerable disruption and existing dissatisfaction with transport in Newbury Town Centre."

In reply to Councillor Mike Johnston's comments, it must be noted that the current lack of a Saturday parking charge in this car park has arisen solely from the use of the car park on Saturdays by the previous holders of the lease of the football club site. This lease is now defunct and it is considered appropriate to implement a Saturday parking charge to bring the car park into line with the Council's other pay to park car parks. The proposed charges are modest and reflect the out-of-town location of the car park. It is not considered that an all-day parking charge of £2.00 (or 20p per hour for the period 8.00am to 6.00pm) is an unfair imposition on motorists to park in a car park with lighting that is regularly maintained and cleaned. Parking controls in this car park are enforced throughout the week and form a routine part of the Parking Inspector's schedules. The Saturday enforcement of this car park can be easily absorbed into the schedule without the need for additional resources.

Appendix A: Summary of the Ward Members Responses

The Ward Members for Falkland; Victoria; Northcroft; Clay Hill; and St Johns wards were consulted in the preparation of this report. All ward members were originally consulted by e-mail sent on 22 May 2007 when the report was scheduled for the Executive. The report was subsequently withdrawn from the Executive and progressed as a report for Individual Decision and a further consultation was issued by e-mail on 19 July 2007. The Ward Members were asked to reply by 24 August 2007.

The result of the consultation with Ward Members is:

Clay Hill Ward

- Councillor Jeff Beck had not replied by the end of consultation period. Any subsequent comments will be verbally reported when the decision is made.
- Councillor Dave Goff had not replied by the end of consultation period. Any subsequent comments will be verbally reported when the decision is made.

Falkland Ward

- Councillor Howard Bairstow had not replied by the end of consultation period. Any subsequent comments will be verbally reported when the decision is made.
- Councillor Adrian Edwards replied on 23 May 2007. He stated:

"I was under the impression that the Bayer car park was free. If so, the second para is strictly not correct."

This report deals with pay to park car parks. The Bayer car park is offered for use on Saturday only and there is no parking charge. This is one of several free car parks provided by the Council. The Football Club has charges all week except Saturday and this is inconsistent with the Council's other pay to park car parks.

Northcroft Ward

- Councillor Tony Vickerws had not replied by the end of consultation period. Any subsequent comments will be verbally reported when the decision is made.
- Councillor Gwen Mason had not replied by the end of consultation period. Any subsequent comments will be verbally reported when the decision is made.

St Johns Ward

• Councillor Mike Johnston replied on 29 May 2007 and stated:

"Thank you for sight of these documents.

One issue I have with having additional charges on outlying car parks is that it will not encourage people to park away from the Town Centre and walk in, it might just encourage people to drive to Town Centre car parks and cause more congestion.

While you estimate that the payback is 8 months against the cost of signs, what additional enforcement will be needed? Will this impact existing enforcement ability as the Football Club is away from the centre, thus there might be lost revenue elsewhere.

Generally, I am not sure if this will be seen as just another tax on the motorist, with no visible benefit at a time of considerable disruption and existing dissatisfaction with transport in Newbury Town Centre."

In reply to Councillor Mike Johnston's comments, it must be noted that the current lack of a Saturday parking charge in this car park has arisen solely from the use of the car park on Saturdays by the previous holders of the lease of the football club site. This lease is now defunct and it is considered appropriate to implement a Saturday parking charge to bring the car park into line with the Council's other pay to park car parks. The proposed charges are modest and reflect the out-of-town location of the car park. It is not considered that an all-day parking charge of £2.00 (or 20p per hour for the period 8.00am to 6.00pm) is an unfair imposition on motorists to park in a car park with lighting that is regularly maintained and cleaned. Parking controls in this car park are enforced throughout the week and form a routine part of the Parking Inspector's schedules. The Saturday enforcement of this car park can be easily absorbed into the schedule without the need for additional resources.
