Supporting Information

- 1. 1. Background
- 1.1 At the January 2007 meeting of the West Berkshire Partnership a presentation was given on the proposal to develop a Strategic Action Plan for Alcohol. The Partnership agreed to support the proposal and requested that a report be brought to a subsequent meeting outlining the process to enable its development. This occurred and as a result the Partnership endorsed the development of the plan.
- 1.2 Following this, the Public Health Departments of both Berkshire West and Berkshire East Primary Care Trusts agreed to collaborate in developing Alcohol Strategies, with the individual unitary area Alcohol Action Plans sitting underneath and a joint Alcohol Conference was held in September 2007. The outcomes were used to inform the development of a Berkshire West Alcohol Harm Reduction Strategy coordinated by the Public Health Director for Berkshire West PCT. This has now been completed and ratified by the Government Office of the South East (GOSE) and a copy is included at Appendix 1.
- 1.3 The Berkshire West Alcohol Harm Reduction Strategy has one overarching aim: 'to improve the health and social well-being of the people who live in, work in and visit Berkshire West by reducing the harms associated with alcohol misuse' and the objectives are:
 - to provide alcohol treatment services for hazardous, harmful and dependent drinkers in an appropriate and timely fashion
 - to reduce long term alcohol related health issues through increasing awareness of the dangers of excess alcohol consumption and how to drink responsibly
 - to decrease drunken behaviour and the associated alcohol-fuelled anti-social behaviour and violent crime
 - to decrease the sale of alcohol to under 18's by licensed and non-licensed retailers
- 1.4 In June 2007 the Government published 'Safe.Sensible.Social The next steps in the National Alcohol Strategy', which built on the strategy for England published in 2004. 'Safe.Sensible.Social.' restated the Government's long term goal, to minimise the health harm, violence, crime and anti-social behaviour associated with alcohol, while ensuring that people are able to enjoy alcohol safely and responsibly.

- 1.5 The National Strategy has three overarching goals:
 - to reduce the levels of alcohol-related violent crime, disorder and anti-social behaviour;
 - to reduce the percentage of the public who perceive drunk and rowdy behaviour to be a problem in their area; and
 - to reduce chronic and acute ill health caused by alcohol, resulting in fewer alcohol-related accidents and hospital admissions.

2. West Berkshire Safer Communities Partnership Alcohol Action Plan 2009

- 2.1 As a result, each of the unitary authorities within Berkshire West agreed to develop their own Strategic Action Plan for Alcohol to sit underneath the Berkshire West Alcohol Harm Reduction Strategy.
- 2.2 In West Berkshire a range of stakeholders and partners were invited to a meeting held in September 2008 to agree a mechanism for developing the West Berkshire Alcohol Action Plan along with David Sheehan, the GOSE Alcohol lead. The meeting included the scoping of existing and planned activity in respect of alcohol, the identification of gaps in activity and the development of actions in respect of these gaps.
- 2.3 A copy of the West Berkshire Alcohol Action Plan 2009 is included at Appendix 2 and progress with implementation of the plan will be monitored by the Drug & Alcohol Action Team (DAAT) Alcohol & Drug Strategy Group. The group meets quarterly and reports to the Safer Communities Partnership Performance Management Group. It fulfils the following purposes, to:
 - Implement the new national Drugs Strategy locally
 - Implement the Berkshire West Alcohol Harm Minimisation Strategy locally
 - Provide a strategic overview and make recommendations to the Safer Communities Partnership
 - Contribute to the annual Partnership Strategic Assessment and the development and delivery of the Partnership Plan
 - Co-ordination and alignment of local responses to need in respect of alcohol and drugs

3. Local Area Agreement 2

- 3.1 The Partnership Strategic Assessments conducted in 2007 and 2008 identified alcohol as a Strategic Priority for the Safer Communities Partnership and in particular Alcohol Related Violent Crime. In addition anti-social behaviour was also identified as a Strategic Priority and the link between alcohol consumption and anti-social behaviour was also explored.
- 3.2 The Community Safety Partnership Plan is the Action Plan for the Partnership Strategic Assessment and in respect of Alcohol the Outcome is to 'Reduce alcohol-related crime and disorder'. This and the other Strategic Priorities identified by the Partnership Strategic Assessment informed the negotiations in respect of the national Indicators included within the Local Area Agreement 2008 2011.

- 3.3 The following National Indicators with links to alcohol have been included in the final set:
 - NI 39 Alcohol related hospital admission rates
 - NI 20 Assault with injury crime rate
 - NI 21 dealing with local concerns about anti-social behaviour and crime by the local council and police

4. Funding for Alcohol

- 4.1 The Drug and Alcohol Action Team (DAAT) receives government funding (Pooled Treatment Budget and Drug Intervention Programme Grant) to commission treatment services for problematic drug misusers. The DAAT commissions T2 (Turning Point) and West of Berkshire Substance Misuse Service to provide drug treatment services.
- 4.2 The DAAT does not receive any government funding to commission alcohol treatment and Berkshire West NHS commissions West of Berkshire Substance Misuse Service to provide alcohol treatment.
- 4.3 The level of alcohol treatment services across the NHS Berkshire West PCT area and in West Berkshire has been assessed by local commissioners and practitioners to be inadequate. The funding for alcohol treatment is within a block contract between NHS Berkshire West PCT and Berkshire Healthcare Trust and has historically been problematic to quantify. However the situation has changed considerably over the last 6-12 months and during 2009/10 the PCT is providing £60,000 to Turning Point to fund Arrest Referral, outreach work and drop in work in relation to alcohol. In addition, the PCT has received £38,630 from a bid to the Greenham Common Trust for funding to continue the work of a Clinical Nurse Specialist for another 12 month period to work in primary care with clients who misuse alcohol. The PCT is also providing funding for 2 alcohol posts within A&E at the Royal Berkshire Hospital, but these are not yet in place.
- 4.4 The West Berkshire Alcohol Action Plan reflects the above and other investment now being put into alcohol treatment by NHS Berkshire West PCT. It also includes activity from other partners such as Thames Valley Police, West Berkshire Council, The Edge and the Community Mental Health Team and has been divided into the following sections:-
 - Alcohol and young people
 - Support for adult alcohol misuse
 - Combating alcohol misuse through engagement

5. Recommendations

- 5.1 That the Portfolio Member notes the contents of this report and gives commitment to the implementation of the West Berkshire Alcohol Action Plan 2009.
- 5.2 That the Portfolio Member receives regular updates on progress with implementation of the plan.
