A340 Tidmarsh Road, Speeding Traffic

Resolved that the following be approved:

1. Roadside speed checks continue on Tidmarsh Road.
2. Ground level vegetation covering the footway is cut back.
3. Further investigation be undertaken to establish the likely cost to widen the footway.
4. The petition organiser be informed accordingly.
5. Revisit within six months to establish if the reduction from 50mph to 40mph has had an impact on the 30mph zone.
