### 4. Background

4.1 The Health and Wellbeing Board conference is held annually. It was opened up to the public for the first time in 2020 and attracted over 100 attendees. Feedback was overwhelmingly positive. As a result, it was agreed that future conferences should be public events.

4.2 This year's event was scheduled to take place on 15 October 2021. However, recent changes within the Berkshire West Clinical Commissioning Group mean that resources will not be available to support the delivery of the conference as planned.

### 5. Options for Consideration

Options include cancelling the conference, or slipping it to a later date.

### 6. Proposal

It is proposed to slip the conference to 21 January 2022. This would be planned and delivered by the Public Health Team and members of the Health and Wellbeing Board Engagement Group, with support from other Board Members as required.

### 7. Conclusion

7.1 Delaying rather than cancelling the conference would retain this valuable opportunity to hold workshops on key health topics, and engage with external stakeholders and

members of the public. It would also provide an opportunity for the Board to promote increased awareness of its works and achievements.

7.2 Postponing the conference to January 2022 would tie in with the launch of the Berkshire West Health and Wellbeing Strategy, which is due to be approved in December 2021. Other topics and speakers would be confirmed in due course.

Discussion has taken place with the Chairman of the Health and Wellbeing Board, Service Director – Communities and Wellbeing and the Chairman of the Health and Wellbeing Board Engagement Group.
