- I am a local resident to Elcot Park Hotel living in West Berks, 7 miles from the hotel on a farm where my wife & I graze livestock. I grew up on farms and indeed my mother and I have a cattle farm / rearing business on our family farm in southern Scotland. Farming is in my blood and the warfare of livestock is of the upmost importance to me.
- The Signet Collection (owners of Elcot Park hotel) is a business I founded in late 2019 to purchase tired yet beautiful hotels that have fallen out of favour through poor upkeep, poor operational standards and lack of investment.
