Members of the Executive to answer the following questions submitted by members of the public in accordance with the <u>Council's Constitution</u>:

(A) Question not related to an item of business to be answered by the Portfolio Holder for Highways, Housing and Sustainable Travel submitted by Lawri Darbyshire:

"West Berkshire Council have recently installed a number of electric vehicle charging bollards, one is outside my house in the street where I live. the houses already have their own driveways, so can pay to install their own chargers if they want. In fact, a lot of houses already have their own private charge points installed.

What are the exact requirements for a local street to qualify or be rejected for W.B.C. funded E.V. charge points?"
