**A. Question submitted to the ICB Executive Director for Berkshire West Place by Paula Saunderson:**

In relation to Agenda Item 8 - ICB Primary Care Strategy:

*“The Primary Care Strategy makes no specific mention of the new highest cause of mortality – a dementia – yet it mentions inequalities several times, and on page 8 where all the roles within your Integrated Neighbourhood Teams are mentioned, there is nothing for dementia as a Severe Mental Impairment (SMI) and no mention of dementia / Admiral Nurses, so how will the Dementia Pathway to death be dealt with under this new model?”*

**B. Question submitted to the Executive Director – Adult Social Care by Paula Saunderson:**

In relation to Agenda Item 16 – Health and Wellbeing Board Sub-Group Updates - Ageing Well Task Group:

*“The Future Actions mentions the Big Dementia Conversation at Shaw House for all Adult Social Care (ASC) Staff in February, so please can you outline what contents will be covered in these training events and how these will align with formal NVQ Training for Dementias?”*
