Item 10 – Appendix D: Feedback from Victims of the Company Sentenced for Unfair Trading

Members will hopefully have read the <u>press release</u> issued on 16th May 2024 about ESE Group Limited (formerly known as ESE Services Limited) and two of its former sales representatives who were sentenced at Reading Crown Court having entered guilty pleas at previous hearings to a range of matters relating to solar systems maintenance.

The two employees were handed suspended prison sentences and ordered to undertake rehabilitation activity.

Following the sentencing hearing, the total amount payable by ESE Group Limited related to their offending amounted to in excess of £1.4 million. This included compensation for the remaining victims making a total recovered for the victims of ESE Group Limited of £326,317.85.

Members will be aware that we always attach a list of compliments received during that quarter to the quarterly performance report to highlight the positive impact the work of the staff in the Public Protection Partnership has had on our residents.

We have received a significant number of 'thank yous' to Martin Woodley and the Investigations Team and Beth Varcoe and her colleagues in the Legal Services Team involved in this case.

Unfortunately, all but the last two, were received too late to include in the paperwork issued for the Joint Public Protection Committee meeting on Monday 10 June 2024.

We felt that on this occasion it would be appropriate to circulate these additional comments now rather than waiting to include them in the October paperwork.

It should be noted that the first complaint regarding this matter was received in 2018. There were significant delays in getting this case through the court system (which were severely impacted by Covid).
