Supporting Information

1. Background

- 1.1 The Standing Advisory Council on Religious Education (SACRE) was established in accordance with Section 390 of the Education Act 1996 by West Berkshire District Council acting as the Local Education Authority.
- 1.2 The SACRE was established to set the RE syllabus, advise the Local Authority on matters connected with religious worship and advise on methods of teaching, the choice of materials used and the provision of training for teachers.

2. Nominations for membership of the West Berkshire SACRE

- 2.1 The standing Advisory Council on Religious Education comprises four groups each with a single vote to use when voting is necessary.

The four groups are:

Group A: Representatives of Christian denominations other than the Church of England and of other religions	Group B: Church of England representatives
Group C: Up to 6 Education Union representatives from the following Unions, with no more than 3 from any one union: NUT, NAS/UWT, ATL, PAT, NAHT, SHA	Group D Representatives of the local authority

- 2.2 The Local Authority is responsible for appointing members to each of these four groups. This is usually achieved by seeking nominations from each area. There are currently two vacancies in Group A and two vacancies in Group B.
- 2.3 A nomination has been received for Mrs Valerie Bolan, a long standing and serving member of St George the Martyr Church, Wash Common, Newbury. If appointed, Mrs Bolan would represent Group B (Church of England representatives) on the West Berkshire SACRE. In addition, a nomination has been received for Mr Mobasshir Mushtaq, an Imam at the Bangladeshi Welfare Centre and Newbury Jamme Mosque. If appointed, Mr Mushtaq would represent Group A (Representatives of Christian denominations other than the Church of England and of other religions). Both nominations have been supported by the Local Stakeholders as set out in the consultation responses. Following consultation no objections were received to this nomination.
- 2.4 It is therefore proposed that these nominations be accepted.
