58 Overview of West Berkshire SACRE - Reverend David Taylor

The Reverend David Taylor (Chairman) welcomed everybody to the meeting and drew the Committee's attention to the document at page 25 of the agenda regarding an overview of the Standing Advisory Council on Religious Education (SACRE). The Committee noted the document.

59 Minutes

The Minutes of the meeting held on 6 February 2018 were approved as a true and correct record and signed by the Chairman, subject to the following amendments:

Membership update - Page 4: 'Debbie Arden-Hunt' to be replaced with 'Debi Arden-Hunt'. David Taylor also corrected that Mrs Arden-Hunt was an IT teacher; she had expressed interest in joining the Committee but had not been able to attend the meeting.

Feedback from Hub meeting - Page 5, 4th **bullet:** replace 'GCSE' with 'Key Stage 4'. **Page 6:** Alison Harris advised that the £30 price for the 'Understanding Christianity' resource was only available to church schools.

60 Matters arising from the Minutes

There were no matters arising from the minutes of the previous meeting.

Pan-Berkshire Agreed Syllabus Draft 6 feedback and actions

Alison Harris introduced draft 6 of the Pan-Berkshire Agreed Syllabus for Religious Education which had been streamlined and made more clear following feedback from teachers. The guidance had been removed and placed into a separate document.

Regarding the remaining actions, Alison noted that the invitations to the launch event had already been dispatched.

David Taylor tabled the wording he intended to use as the foreword for the document. The Committee commended and approved the foreword.

Bernard Eggleton queried the use of vocabulary such as 'holistic' and 'experiential' and asked if these words were sufficiently clear. The Committee held a discussion and concluded that the vocabulary was used by teachers and therefore would be clear to them as the main audience of the document.

David Taylor enquired how the document would be printed and disseminated. Jo Reeves advised that the Committee could ask the Council's print room to print the document.

Action: Jo Reeves/ Jo Watt to organise printing of the final document.

David Taylor advised that he would like to provide paper copies of the syllabus at the launch event.

Mobasshir Mushtag joined the meeting at 4.35pm.

62 Pan-Berkshire Agreed Syllabus launch event

David Taylor advised that so far nine out of ten secondary schools and 46 teachers representing 31 of the District's 49 primary schools had accepted the invitation to the Syllabus launch event. The event would be held on Tuesday 3rd July 2018, 4.15pm – 5.30pm at Thatcham Baptist church. David Taylor asked that members of the Committee informed him if they planned to attend. He also stated that he would be grateful of any assistance that the Committee could offer to set up the venue on the day.

63 Budget for 2018/19 and action plan

David Taylor tabled an updated version of the SACRE budget for 2018/19.

Following discussions with the hub at Wokingham, it had been agreed to continue making a contribution. Albeit reduced form the budget included in the agenda. It had also been determined that it would not be a priority to hold a conference so the budget line would be removed.

David Taylor asked the Committee whether, when the syllabus was refreshed again in 2023, they should consider asking the local authority for an enhanced budget or if the Committee should attempt to carry over savings in preparation. Alison Harris advised that the funding landscape might be different in five years' time and suggested that the Committee continue to spend their allocated budget as intended.

Robin Sharples suggested that the Committee write to the local authority on the subject.

Action: Alison Harris to include a letter in the action plan.

Alison Harris informed the Committee that at the syllabus launch event, she would appeal to schools to host the RE network meetings and find out from teachers what they would like from the meetings.

64 Ramadan briefing paper - Mobasshir Mushtaq

The Committee thanked Mobasshir Mushtaq for the helpful briefing paper regarding Ramadan. Mobasshir advised that he would like to make some final amendments to the formatting of the document in advance of it being circulated to schools.

Action: Mobasshir Mushtaq to send a final version of the briefing paper to Jo Watt to circulate to all headteachers.

Alison Harris asked to share the document with Wokingham as headteachers in that area would also find the document helpful.

Keith Harvey noted that his school would be taking a residential trip during Ramadan and the document would assist him to understand the needs of a Muslim pupil.

65 Any Other Business

Bernard Eggleton reported that he had been concerned to read an article in the i newspaper regarding parents withdrawing their children from RE only when Islam was being taught. Robin Sharples noted that under the legislation parents were able to pick and choose in what RE their children participated.

Alison Harris noted that a motion had been put to the National Association of Head Teachers (NAHT) conference that it would be impossible for schools to fulfil their responsibilities under the Prevent strategy if they were not able to teach all children Islam.

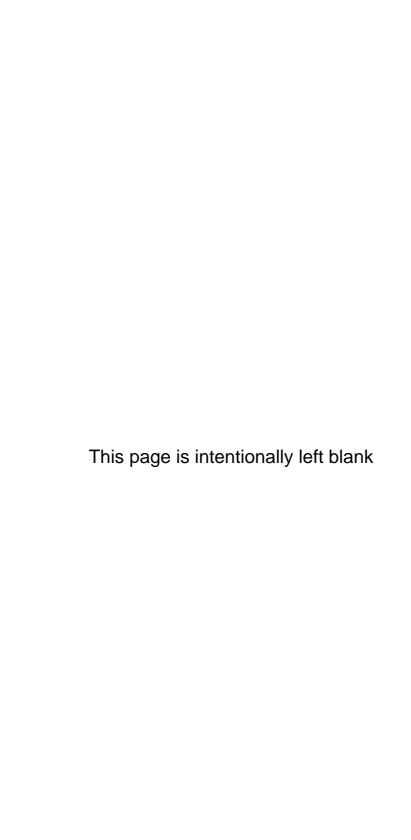

Mobasshir advised that they were disappointed to be refused planning permission and would try again.

David Taylor asked whether the Committee had ever looked into whether there was a Jewish community in West Berkshire. Mary Harwood advised that she had asked the Rabbi in Reading but they were unaware of any families in the area.


Dear Reverend Taylor,

Thank you for your letter of 13 July, addressed to the Secretary of State, regarding religious education. I am replying as the Minister of State for School Standards.

As you are aware, religious education is compulsory for all pupils, including those in sixth form. While we would prefer schools to deliver religious education of their own accord, the Secretary of State has powers to intervene where a school is not meeting its statutory duty. However, I would suggest that the local authority or the SACRE first contacts those schools not complying with the locally agreed syllabus to remind them of their legal duty, and asks for confirmation that these schools have taken action to meet it.

If this is unsuccessful, a complaint could then be referred to the Secretary of State, giving details of what the agreed syllabus requires of the school, all communications with the school regarding this issue, and the school's response. Please send any such complaint, marked for the attention of Neil Lawson, to: curriculumsupport.team@education.gov.uk.

The religious studies A level attracts UCAS points for those students who take it. Although the subject of religious education has compulsory status, there are reasons why it might not be practicable for it to attract UCAS points in its own right. For example, as each local authority area has its own agreed religious education syllabus, these may impose different requirements on schools, making it difficult to determine how many points to award.



In addition, UCAS points are awarded for grades achieved, rather than on the basis of having been taught for the specified number of hours. However, UCAS is an independent organisation, and this is ultimately a matter for it to decide.

Annual SACRE Report 2017-2018

What is a SACRE?

The Standing Advisory Council on Religious Education has several aspects to its role. It:

- Advises the local authority on matters relating to collective worship and religious education
- Advises on methods of teaching and resources for religious education
- Decides whether or not to grant determinations to those schools which apply to have daily worship which is other than of a broadly Christian character
- Identifies the need for a revised religious education syllabus

To help with this endeavour the West Berkshire SACRE works with NASACRE (the National Association of SACREs). It has also joined with five other neighbouring SACREs to form the Pan-Berkshire SACRE Hub in order to undertake more significant projects than it could manage alone.

This report sets out a brief summary of the work of the West Berkshire SACRE over the academic year 2017-2018. The minutes of the meetings which give more detail can be found at

Membership

Clare Nolan (Group C) resigned from the committee as she could not get there on time, but has since indicated her willingness to return now that the meeting time is slightly later. It is extremely valuable to have serving teachers on SACRE, and we are still seeking a representative from amongst our 59 Primary Schools. Mark Landreth-Smith from The Bridge Church attended two meetings as an observer.

At the end of the year Jo Watt moved on from her position at the Council. We expressed our grateful thanks to Jo for the tremendous quality and quantity of support she had given us during her time as Clerk and wished her well for the future.

Meetings

Three meetings were held during the year: 7 November, 6 February and 15 May. Thanks go to St Nicolas' School in Newbury and Head Teacher Keith Harvey for hosting 2 of these meetings, with the 3rd being held at West Berkshire Council.

In November we agreed to amend the definition of our quorum to "a minimum of 6 members (including at least one Advisor), representing at least 3 of our 4 membership groups." This seems to have solved the issue of meetings being inquorate.

New Syllabus

Much of our activity this year was connected with the preparation of the Pan-Berkshire RE Syllabus 2018-2023 and our event to launch this in W Berks, which took place at Thatcham Baptist Church on 3 July. This was attended by nearly 80 people including 60 teachers and 9 representatives of local interested organisations. Alison Harris guided teachers through the main points of the new syllabus, David Taylor was able to gather secondary colleagues together for their own discussion, and there was much useful informal networking.

Although still in its early days, the new Syllabus seems to have been received warmly by teachers. Broadly, teachers had called for as little change as possible. Accordingly the new document is much like the old one in terms of subject content, though considerably slimmed down for the sake of clarity. The main changes are as follows:

- The boundary between KS1 and KS2 has been removed allowing teachers more flexibility. The inclusion of Islam at Primary level seems to have been happening in many schools already.
- KS3 is now to include a non-religious worldview such as Humanism since this is now the air most young people breathe in their day-to-day lives.

- There is a strong recommendation that all pupils should have access to RS at GCSE level. In 2018, of our 10 mainstream secondary schools, 5 offered GCSE to all, 4 offered it as an option, and one did not offer it at all. Detailed GCSE results are listed below.
- At post-16 we now recommend 10 hours per year rather than 6. We realise that this is an issue we need to address as most schools seem to be completely failing in this area.

Other Actions and Budget

With several new members joining the committee this year, we took time to revisit our core purposes. In the light of this we made efforts to allocate our budget for 2018-19 somewhat differently, in order to support teachers more. In particular we wanted to release funds for an Advisor to attend teachers' network meetings, especially as they get to grips with the new Syllabus. We did this by reducing our contribution to the Berkshire Hub (in line with the other Berkshire SACREs), and writing our own Annual Report. There was no SACRE conference in 2018-19 so this was also removed from the budget.

Other items discussed during the year included the *Crossing the Bridges* project, RE trails, and support for pupils fasting for Ramadan during exams.

David Taylor used a sabbatical from his day job to visit secondary RE teachers across the district in their departments. We hope this will lead to a stronger relationship and better communication between the schools and SACRE. He provided them with a list of potential speakers from local faith communities willing to visit schools to give talks on a range of subjects connected with RE, and some of these have started to be used.

Most teachers were clearly doing a fine job. However one focus of concern was Park House School in Newbury where RS is not currently being adequately provided. David Taylor and Mark Landreth-Smith met with the Headteacher and other colleagues in August to discuss this situation, which we hope will improve next year.

The Hub

SACRE Chairs and professional advisers to the SACREs continued to meet to discuss work undertaken at hub level. The leadership of the hub recently passed from Jan Lever to Anne Andrews (Oxford Diocese) and David Rees (Reading Advisor).

The SACRE continues to be a member of the National Association of SACREs (NASACRE) to ensure members remain well informed about national debates relating to RE.

General interest

In addition to the above aspects of the SACRE's most significant work, members engaged in fruitful discussions about a range of topics, including consideration of published national documents regarding the provision of RE across the UK plus items of local consideration.

Collective Worship

It has not been necessary to renew any determinations during this year. A determination is permission for a school to provide daily collective worship which is not 'wholly or mainly of a broadly Christian character'.

Public Examination Results

In 2018 there were 1010 entries for GCSE Religious Studies. There was a 99% pass rate, with 69% achieving grade 4 or above, as compared to 71.8% nationally. This represents an improvement on last year's performance.

There were 19 entries for A level Religious Studies: There was a 100% pass rate, with 74% achieving grade C or above.
