#### 5. Supporting Information

##### Berkshire Maestros

- 5.1 Berkshire Maestros meet six times a year and meetings are usually held at 6pm, for approximately two hours. Berkshire Maestros work across Berkshire offering music lessons, ensembles and other musical opportunities to over 4,500 children and young people.
- 5.2 The Council representative will be expected to advise the Berkshire Maestros Board on local initiatives and networks.
- 5.3 West Berkshire Council had previously elected a Councillor for Berkshire Maestros in 2015, however there has been no representation since 2019. Councillor Owen Jeffery has been nominated, and approval is being sought for their nomination.
- 5.4 The appointment will run until May 2023 when the full term of all other current representatives terminates and will be reviewed.
