1. Purpose of the Report

1.1 To set out the background information pertaining to this Licensing Application.

2. Recommendation

- 2.1 Members are asked to decide whether to:-
 - a) Grant the application for a premises licence subject to such conditions as are consistent with the operating schedule accompanying the application and to decide whether to modify any of those conditions to such extent as is considered appropriate for the promotion of the licensing objectives and subject to any mandatory conditions;
 - (b) Refuse to specify a person in the licence as the Designated Premises Supervisor;
 - (c) Exclude from the licence any of the licensable activities to which the application relates;
 - (d) Reject the application for a premises licence

Members of the Licensing Sub-Committee are asked to make a decision at the end of the hearing after all relevant parties have been given the opportunity to speak. Members must give full reasons for their decision.

3. Background

- 3.1 Members of the Licensing Sub-Committee are asked to determine the application as the Licensing Authority has received representations stating that granting this application would undermine the prevention of crime and disorder, the prevention of public safety, the prevention of public nuisance, and/ or the protection of children from harm licensing objectives.
- 3.2 The Licensing Authority may only consider aspects relevant to the application that have been raised in these representations.

3.3 Where representations have been received from a responsible authority or any other person, and the concerns have not been resolved through mediation between all parties, the Licensing Act 2003 requires that these applications should be determined by the Licensing Authority's Licensing Committee. The Licensing Act 2003 allows for applications such as this one to be delegated to a Sub-Committee. In accordance with those rules, the Scheme of Delegation set out in the Council's Constitution states that the Licensing Sub-Committee has responsibility for dealing with this application.

4. Background

4.1 The Licensing Authority had received an application, from Bite Express Ltd, for a premise licence in relation to 63A Bartholomew Street, Newbury, RG14 7BE. This application had been recorded under reference number 21547 on 13 April 2023. A copy of the application, including a location map, is attached as Appendix 1.

5. Consultation

- 5.1 The 28 day consultation period ran from 14 April 2023 to 11 May 2023. Responsible Authorities, Ward Members and the Parish Council were advised by email on the 14 April 2023. The application has been advertised in accordance with the regulations, with the required blue notices being placed at the premises and checked by an officer from the Public Protection Partnership and an advert was placed in the Newbury Weekly News.
- 5.2 The applicant emailed the licensing authority on the 10 May 2023 to amend the proposed opening hours of the premises. This information is set out in Appendix 2.
- 5.3 A table setting out the 18 representations, a query and one comment which has been classes as a relevant representation is attached at Appendix 3.

6. Outline of the Application

- 6.1 The application originally sought to obtain the following provisions of licensable activities
 - F. Recorded Music: Monday to Sunday from 08h00 to 23h00 to take place indoors only
 - I. Late Night Refreshment: Monday to Sunday 23h00 to 02h00 to take place both indoors and outdoors
 - J. Supply of Alcohol: Monday to Sunday from 11h00 02h00 for the supply of alcohol for consumption both on and off the premises.
- 6.2 The revisions to the application proposed by the applicant are as follows:
 - Sale of Alcohol being reduced from 11h00 02h00 Monday to Sunday to 11h00 – 00h00 Monday to Sunday;
 - Late Night Refreshment being reduced from 23h00 02h00 Monday to Sunday to 23h00 – 00h00 Monday to Sunday;

- Recorded Music being reduced from 08h00 23h00 Monday to Sunday to stay the same but to be reiterated that the music will be incidental background music only
- Opening Hours to the public being amended rom 11h00 02h00 Monday to Sunday to 08h00 – 00h00 Monday to Sunday
- 6.3 The applicant has also agreed additional conditions with Thames Valley Police (see Appendix 4)

8. Options

- 8.3 If Members are minded to approve the application they need to consider any additional conditions, other than those contained in the operating schedule, the conditions requested by Thames Valley Police and any relevant mandatory conditions in ss19-21 of the Licensing Act 2003. Modification of conditions includes adding, omitting or altering a condition;
- 8.4 If Members are minded to include any additional conditions they will need to provide their reasons for doing so in the decision notice.





b) The prevention of crime and disorder

CCTV System installed to monitor entrances, exits, and other parts of the premises in order to address the prevention of crime objective.

A clear and legible notice outside the premises indicating the normal hours under the terms of the premises licence during which licensable activities are permitted.

Prevention and vigilance in illegal drug use in the premises.

c) Public safety

Training and implementation of underage ID checks. A log book or recording system shall be kept upon the premises in which shall be entered particulars of inspections made.

The log book shall be kept available for inspection when required by persons authorised by the Licensing Act 2003 or associated legislation.

Health and Safety Risk assessments will be undertaken and staff shall be trained therein.

d) The prevention of public nuisance

Prominent, clear and legible notices will be displayed at the exit requesting the public to respect the needs of nearby neighbours and residents and to leave the premises and the area quietly.

Deliveries of goods necessary for the operation of the business will be carried out at such a time or in such a manner as to not disturb the neighbours and in line with planning permission.

e) The protection of children from harm

Only photographic ID is accepted (passport, driving licence, proof of age card with PASS hologram, or military ID). Anyone who appears to be under the age of 25 is challenged to provide ID. If the customer is unable to provide identification then no sale is made. No ID no sale, Challenge 25 POS will be on display in the store. Any staff member who may be under the age of 18 must call a senior staff member to take over the sale and complete the transaction, if it is known that a customer intends to purchase alcohol to provide to minors then that sale will be refused. All refused sales will be recorded in a refusals book, which will be made available for inspection by Police or Licensing Officers of the council on request.

All children on the premises will be supervised/ accompanied by an adult after 21:00 hours

We live around the corner from 63A Bartholomew Street, on Pound Street. As you and your colleagues at the council may know, the area has had a bit of a problem with crime and antisocial behaviour, especially the kind of offences that consumption of alcohol provokes and encourages (criminal damage, public order offences, antisocial behaviour and violent and sexual offences). In the last 12 months, half of the reported crimes in the immediate area have been of this nature, usually taking place late at night/in the early hours of the morning, most often around Pound Street and Argyle Road.

While we totally support all of the local public houses and hospitality venues that serve alcohol, we do have some concerns that the hours included in this application would continue to encourage the very antisocial behaviour that local law enforcement, the council and the local Neighbourhood Watch have been working hard to stop. It doesn't seem necessary that the premises be authorised to sell alcohol until 2am every day of the week, when even the vast majority of local public houses close at 11pm (calling time on alcohol well before that point).

We'd really like the licensing team to take this fact into consideration when looking at the proposed application.

That said, we're glad that the building is being taken over and hope that the new owners will have great success with the business.

Additional Conditions Proposed by Thames Valley Police and Accepted by the Applicant

CCTV

The premises shall install and maintain a comprehensive CCTV system. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.

The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.

All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings will be made available immediately upon the request of Police or authorised officer of West Berkshire Borough Council throughout the entire 31-day period.

A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police officer or authorised officer of West Berkshire Borough Council copies of recent CCTV images within 48 hours.

INCIDENT AND REFUSALS REGISTER

All incidents which impact on any of the four licensing objectives shall be recorded in a register kept at the premises for this purposed. The names of the person recording the incident and those members of staff who deal with any incident shall also be recorded. Where known, any offenders name shall also be recorded;

This record shall be available for inspection by a Police Officer or an authorised officer of West Berkshire Borough Council upon request and shall be retained for one year. The record shall be signed off by the DPS or nominated representative on a monthly basis.

Alcohol may only be served or sold to customers either dining in the restaurant or whilst waiting for a takeaway, or part of an order that is to be delivered. All customers consuming alcohol on the premises must be seated.

Clear and legible notices must be prominently displayed at all exits requesting customers to respect local residents and leave the area quietly.

STAFF TRAINING

Staff employed to sell alcohol shall undergo training upon induction. This shall include, but not be limited to:

The premises age verification policy

- The law relating to underage sales
- Dealing with refusal of sales
- Proxy purchasing
- Recognising valid identity documents not in the English language

Such training sessions are to be documented and refreshed every six months. Records of training shall be kept for a minimum of one year and be made available to an authorised officer of Thames Valley Police and West Berkshire Borough Council upon request.

Sales of alcohol for consumption via takeaway or delivery shall be ancillary to the provision of food. This condition does not apply to any outside area of the Premises.

DELIVERY CONDITIONS

Deliveries shall only be made to a full and proper residential or commercial postal address.

Deliveries shall not take place to car parks, bus shelters, recreation grounds, fields etc.

On all occasions for whatever reason, it has not been possible to deliver an order, full details will be recorded in the refusal register.

AGE VERIFICATION

The premises shall at all times operate an age verification policy of Challenge 25 to prevent any customers who appear to staff members to be under the age of 25 years from purchasing alcohol without having first provided identification.

Only a valid driver's licence showing a photograph of the person, a valid passport, national identity card or proof of age card showing the "PASS" hologram are to be accepted as identification.
