## 1. Purpose of the Report

1.1. To set out the background information pertaining to this Licensing Application.

## 2. Recommendation to Licensing Sub-Committee

- 2.1. Options available to Members are to:-
  - (a) Grant the application for a premises licence subject to such conditions as are consistent with the operating schedule accompanying the application and to decide whether to modify any of those conditions to such extent as is considered appropriate for the promotion of the licensing objectives and subject to any mandatory condition.
  - (b) Refuse to specify a person in the licence as the Designated Premises Supervisor.
  - (c) Exclude from the licence any of the licensable activities to which the application relates.
  - (d) Reject the application for a premises licence.

Members of the Licensing Sub-Committee are asked to make a decision at the end of the hearing after all relevant parties have been given the opportunity to speak. Members must give full reasons for their decision.

#### 3. Introduction and Background

- 3.1. On 23 July 2025, an application was received by the Council on behalf of Karen Blakey, for a new premises licence under Section 17 of the Licencing Act 2003 in respect of The Fuel Boat (registered name Frederick, Station Road (Kennet & Avon Canal) Kintbury. The application was validated on 02 May 2025 and the consultation period expired on the 23 July 2025.
- 3.2. The Responsible Authorities were notified on the 23 July 2025.
- 3.3. Members of the Licensing Sub-Committee are asked to determine the application as the Licensing Authority has received representations stating that the grant of this application

- would undermine the prevention of crime and disorder, the prevention of public nuisance, public safety and/or the protection of children from harm licensing objectives.
- 3.4. The Licensing Authority may only consider aspects relevant to the application that have been raised in these representations.
- 3.5. Members of the Licensing Sub-Committee are requested to determine the application having regard to the operating schedule, representations received, the Councils Statement of Licensing Policy, revised guidance issued under Section 182 of the Licensing Act 2003 and the four licensing objectives.
- 3.6. An authorisation is required in respect of any premises where it is intended to conduct one or more of the licensable activities, these being:
  - (a) Sale of alcohol
  - (b) Supply of alcohol (in respect of a club)
  - (c) Regulated Entertainment
  - (d) Provision of Late-Night Refreshment

An appropriate authorisation is either, a premises licence, a club premises certificate, or a Temporary Event Notice.

3.7. Licence holders are required, when offering any licensable activity, to ensure that they promote the licensing objectives at all times. The operating schedule of the application contains detail of all the activities applied for and the control measures that the applicant will have in place in order to promote these objectives. Such measures will, where appropriate be converted into enforceable conditions on any licence issued.

The four licensing objectives are:

- (a) Prevention of crime and disorder
- (b) Prevention of public nuisance
- (c) Public Safety
- (d) Protection of children from harm.

No licensing objective carries any more weight than any other and these are the only factors in which licensing can have regard in determining an application.

3.8. Where representations have been received from a responsible authority or any other person, and the concerns have not been resolved through mediation between all parties, the Licensing Act 2003 requires that these applications should be determined by the Licensing Authority's Licensing Committee. The Licensing Act 2003 allows for applications such as this one to be delegated to a Sub-Committee. In accordance with those rules, the Scheme of Delegation set out in the Council's Constitution states that the Licensing Sub-Committee has responsibility for dealing with this application.

## 4. Summary of Application sought.

- 4.1. The Licensing Authority received a valid application on 23 July 2025 from Michael Nickson acting as an agent on behalf of Karen Blakey seeking a new premises licence under the Licensing Act 2003 for The Fuel Boat (registered name Frederick, Station Road (Kennet & Avon Canal) Kintbury. This application is recorded under reference 27719. A copy of the application is attached as **Appendix 1** and the plan of the premises is attached as **Appendix 2**. The details of the Designated Premises Supervisor are attached as **Appendix 3**.
- 4.2. The application seeks a premises licence to permit the following licensable activities:-

## **Supply of Alcohol:**

Monday - Sunday 09:00hrs - 23:00hrs - March to October (inclusive) - Off the premises

Monday – Sunday 09:00hrs – 21:00hrs – November to February (inclusive) – Off the premises

## 5. Background information

- 5.1. The Fuel Boat (Registered name Frederick) moors near Station Road, in the town of Kintbury.
- 5.2. The Fuel Boat is a diesel-powered canal narrowboat approximately 21.3m in length and approximately 2m in width. It is registered with the Canal & River Trust under registration number 520859. It operates with a Roving Traders Licence as a fuel boat selling diesel, smokeless fuels, chandlery and basic boating items for boaters and walkers along the towpath.
- 5.3. The application seeks to obtain authorisation for one licensable activity: Sale of Alcohol.
- 5.4. The Sale of Alcohol will be for consumption OFF the premises.
- 5.5. The applicant has provided additional conditions to the mandatory conditions in their application for a premises licence.

#### 6. Consultation

- 6.1. The 28-day consultation period ran from 23 July 2025 to 20 August 2025. Responsible Authorities were advised by email on the 23 July 2025. The application has been advertised in accordance with the regulations, with the required blue notices being placed at the premises, which were checked by an officer from the Public Protection Partnership. An advertisement for this application was also placed in the Newbury Weekly News on 31 July 2025.
- 6.2. A total of 2 representations were received and found to be valid. The 2 valid representations are attached at **APPENDIX 4**.

#### 8. Summary of Relevant Representations

- 8.1. The 2 representations received within the consultation period objecting to the application believe that the granting of the licence would undermine at least one of the licensing objectives.
- 8.2. The main concerns raised in the representations from objectors are risks associated with Public Safety.
- 8.3. During the mediation process, the applicant's agent has been sent these representations, and the applicant has agreed to join the relevant Pubwatch in line with the objection by Public health which was then withdrawn on this agreement. The applicant is currently in communication with the Canal & River Trust regarding obtaining the correct permissions to operate on the waterways.

#### 9. Options

- 9.1. The Home Office's Revised Guidance issued under section 182 of the Licensing Act 2003 (February 2025) must be taken into account when determining this Application.
- 9.2. Members are asked to consider, after taking the representations both oral and written into account, and having due regard to the licensing objectives, whether the application for the Premises Licence should be granted or rejected. Members will need to give reasons for their decision.
- 9.3. If members are minded to approve the application, they need to consider any additional conditions, other than those contained in the operating schedule, and any relevant mandatory conditions in ss19-21 of the Licensing Act 2003. Modification of conditions includes adding, omitting or altering a condition.
- 9.4. If members are minded to include any additional conditions, they will need to provide their reasons for doing so in the decision notice.

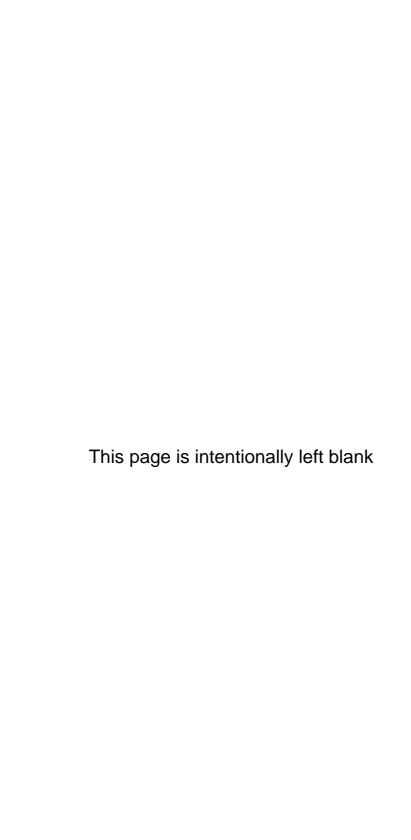

## a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

- A written notice of 'authority' record shall be maintained by the premises licence holder for all staff who sell alcohol
- There shall be comprehensive training for staff in the main requirements of the Licensing Act 2003, the specific measures and conditions in place to promote the Licensing Objectives and the staff roles and responsibilities. Such records shall be available for inspection by the responsible authorities.
- Customers shall not be permitted to board the vessel
- Alcohol products must be sold and leave the vessel in sealed containers

## b) The prevention of crime and disorder

- CCTV coverage shall be provided in the form of a recordable system, capable of providing pictures of evidential quality in all lighting conditions particularly facial recognition.
- Cameras shall encompass all ingress and egress to the vessel and the point of sale of alcohol.
- Equipment shall be maintained in good working order and checked every 12 months.
- The system shall record in real time and operate whilst the premises are conducting licensable activities.
- The recordings shall be kept available for a minimum period of 28 days and handed to Police or Local Authority Officer on request.
- The Recording equipment shall be kept in a secure environment under the control of the Premises Licence Holder or other responsible named individual.
- Appropriate signage representative of the above shall be displayed in conspicuous positions.
- There will be sufficient members of trained staff available to be able to download evidence with the minimum of delay at the request of the Police or Local Authority approved officer
- Staff shall be trained on security issues including how to identify and refuse service to customers that are drunk or appear to be drunk.

## c) Public safety

- The sale of alcohol shall only be permitted when the vessel is stationary
- The approved arrangements at the vessel, including means of escape provisions, emergency warning and life saving equipment, the electrical installation and mechanical equipment, shall at all material times be maintained in good condition and full working order.
- The means of escape provided for the vessel shall be maintained unobstructed and free of trip hazards.

#### The prevention of public nuisance

• No waste or recyclable materials, including bottles, shall be moved within, removed from or placed in outside areas between (22.00) hours and (08.00) hours on the following day

#### d) The protection of children from harm

- The business will be promoted as family friendly and suitable for all ages. Should children be in attendance, there will be no inappropriate promotions, activities or behaviour tolerated at the vessel that might put children at risk.



The craft is registered as a Continuous Cruiser, Roving Trader Roving traders | Starting a boat business?

Some roving traders have a home mooring, but Frederick (520859) does not and as such is required to <u>comply with the guidance for boaters without a home mooring</u> and published time limits at visitor moorings at all times. Given this the craft will be trading from multiple locations across the network and does not have on single permanent trading location.

The British Waterways Act 1995 states that if you don't have a home mooring, you must be undertaking 'bona fide navigation'. Bona fide is a legal term meaning 'good faith', and 'bona fide navigation' means that you are genuinely cruising a fair range of the network. The law does not stipulate how far you must cruise or how often you must move, but customers should be on a continuous journey, not just moving backwards and forwards along one stretch of water. This generally means no longer than 14 days on most of the network or less where signs indicate. Visitor moorings in popular locations are frequently limited to 1, 2 or 5 days to enable everyone to enjoy the facilities.

Given this it is likely that the operator will trade in more than one Local Authority and therefore will require multiple Premises Licences (one for each Local Authority).

The Trust have a process to review and assess new proposals. Customers are required to submit an operating proposal via our online system for appraisal. If approved they can proceed to purchasing a business licence or approval for their existing licence to include the additional trading elements. If approved we require a copy of the public liability insurance, risk assessment and Premises & Personal Licence. We have received an operating Proposal 05/08/25 for the inclusion of general items for sale and also the sale of alcohol from the craft Frederick. Our target response date is 22/09/25. We have wrote to Miss Blakely (Butt) on 19/08/25 requesting further information to support her application. At this time Miss Blakey has not supplied the required documentation for the Trust to be able to make a decision at the time of writing the representation whether to grant or refuse the application. As alcohol and fuel are both flammable liquids and pose serious combined fire risks we are at this time unable to approve the submission with the detail provided.

We have requested a revised submission that includes:

- •A detailed plan and layout showing the location and separation of alcohol and fuel storage. Combined storage of fuel and alcohol is not permitted, regulations require separate storage solutions. Alcohol and fuel should not be stored together in the same room, instead separate, ventilated, fire-rated storage areas are required. If there are only small quantities to be kept then approved safety cabinets can be provided but ignition sources are to be kept away. We have requested a plan demonstrating this.
- •Specifications of ventilation systems and ignition source controls.
- •Confirmation of compliance with relevant fire safety codes adhere to fire safety regulations, HSE Guidance: HSG51-storage of flammable liquids in containers.

•Clarification on residential use and associated safety measures - how will the operator safely separate living accommodation from the Fuel and alcohol spaces.

They will need to consider escape routes, ensure adequate ventilation and spill containment, good house keeping and leak checks.

It is advised that operators limit stock to small quantities, keeping only the amounts needed for one working shift and store the rest away properly. Given the craft is the operators main base we are unsure if they have the option to do this and instead all stock will be kept on the boat. This does pose a higher risk. As the operator is trading on a continuous cruising basis, it is likely require they will trade in more than one Local Authority. We will require evidence of Premises Licence for each Local Authority to support the Operating Proposal before we can provide approval.

At this time the Trust are unable to make a decision at the time of writing the representation and have therefore had to object to the application. As alcohol and fuel are both flammable liquids and pose serious combined fire risks we are at this time unable to approve the submission with the detail provided.
