Members' attention is drawn to the following notes:

1. The Council's Code of Conduct provides for registration and disclosure of pecuniary interests and interests other than pecuniary interests. This form gives general guidance on those interests that need to be disclosed if you need advice or assistance please speak to the Clerk of the Parish Council. Continuation sheets should be used where needed and clearly marked.

3. A 'Sensitive Interest' is an interest which could create or is likely to create a serious risk that you or a person connected with you may be subjected to violence or intimidation.
4. Where the interest is no longer a 'Sensitive Interest' you must notify the Monitoring Officer within 28 days of that change.
5. Reference to Member is taken to include an elected or co-opted member to the Parish Council.
6. The Clerk is required to ensure that a copy of the Parish Council's Register of Interests is both available for inspection and also that the Register is published on its website or West Berkshire Council's website.
