- (a) I understand that I must, within 28 days of becoming aware of any new or change in the above interests, including any change in relation to a sensitive interest, provide written notification to the Council’s Monitoring Officer.
- (b) I confirm that I understand and accept that that it is a breach of the Council’s Code of Conduct to:
 - (1) omit information that ought to be given in this Form;
 - (2) provide information that is materially false or misleading;
 - (3) fail to give further notices in order to:
 - bring up to date information given in this Form;
 - declare an interest that I acquired after the date of this Form and have to declare

and that any breach of the Code of Conduct can be referred to the Monitoring Officer for action.

- (c) I understand that failure (without reasonable excuse) to register or disclose any disclosable pecuniary interest in accordance with section 30(1) or 31(2), (3) or (7) of the Localism Act 2011, or participating in any discussion or vote in contravention of section 31(4) of the Localism Act 2011, or taking any steps in contravention of section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a member for a period not exceeding 5 years.
